# NEW REGULARITY RESULTS FOR SCALAR CONSERVATION LAWS, AND APPLICATIONS TO A SOURCE-DESTINATION MODEL FOR TRAFFIC FLOWS ON NETWORKS*

#### Abstract

We focus on entropy admissible solutions of scalar conservation laws in one space dimension and establish new regularity results with respect to time. First, we assume that the flux function $f$ is strictly convex and show that, for every $x \in \mathbb{R}$, the total variation of the composite function $f \circ u(\cdot, x)$ is controlled by the total variation of the initial datum. Next, we assume that $f$ is monotone and, under no convexity assumption, we show that, for every $x$, the total variation of the left and the right trace $u\left(\cdot, x^{ \pm}\right)$is controlled by the total variation of the initial datum. We also exhibit a counterexample showing that in the first result the total variation bound does not extend to the function $u$, or equivalently that in the second result we cannot drop the monotonicity assumption. We then discuss applications to a source-destination model for traffic flows on road networks. We introduce a new approach, based on the analysis of transport equations with irregular coefficients, and, under the assumption that the network only contains so-called T-junctions, we establish existence and uniqueness results for merely bounded data in the class of solutions where the traffic is not congested. Our assumptions on the network and the traffic congestion are basically necessary to obtain well-posedness in view of a counterexample due to Bressan and Yu. We also establish stability and propagation of $B V$ regularity, and this is again interesting in view of recent counterexamples.

1. Introduction and main results. We organize the introduction into two main parts: in the first one we discuss the regularity results, in the second one the applications to a traffic model. We conclude the introduction by providing the paper outline and recalling the main notation used in the paper.
1.1. Time regularity results for scalar conservation laws. We consider a scalar conservation law in one space dimension,

where $f \in C^{2}(\mathbb{R})$, and for the time being we focus on the Cauchy problem obtained by coupling (1.1) with the initial datum

The milestone paper by Kružkov [33] establishes existence and uniqueness results for so-called entropy admissible solutions of the Cauchy problem (1.1), (1.2). It also

[^0]establishes propagation of bounded total variation $(B V)$ regularity: if $u_{0} \in B V(\mathbb{R})$, then the entropy admissible solution $u$ satisfies $u \in L^{\infty}\left(\mathbb{R}_{+} ; B V(\mathbb{R})\right)$ and by using the equation this yields $u \in B V(] 0, T[\times \mathbb{R})$ for every $T>0$. Since the pioneering work of Olĕnik [37], the investigation of the regularity properties of entropy admissible solutions has received considerable attention: here we only refer for an overview to the book by Dafermos [23], to the recent contributions [4, 10, 11, 21, 32, 36], and to the references therein.

Our first regularity result establishes a uniform control on the total variation in time of the flux function $w:=f \circ u$ evaluated at any fixed $x \in \mathbb{R}$. Despite the fact that the set $\{(t, y): y=x\} \subseteq \mathbb{R}^{2}$ is negligible, the function $w(\cdot, x)$ is well defined owing to [23, Lemma 1.3.3]; see also Lemma 2.1 and Remark 2.2 in the following.

ThEOREM 1.1. Fix $f \in C^{2}(\mathbb{R})$ with $f^{\prime \prime} \leq 0$ or $f^{\prime \prime} \geq 0$ and assume $u_{0} \in B V(\mathbb{R})$. Let $u$ be the entropy admissible solution of the Cauchy problem (1.1), (1.2) and set $w:=f \circ u$; then

\end{equation*}

In the previous expression, we have set $w_{0}:=f \circ u_{0}$ and $\left\|f^{\prime}\right\|_{L^{\infty}}:=$ $\max _{u \in\left[\text { ess } \inf u_{0}, \text { ess } \sup u_{0}\right]}\left|f^{\prime}(u)\right|$.

Note that, in (1.3), $C\left(\operatorname{Tot} \operatorname{Var} u_{0},\left\|f^{\prime}\right\|_{L^{\infty}}\right)$ denotes a constant only depending on TotVar $u_{0}$ and on the Lipschitz constant $\left\|f^{\prime}\right\|_{L^{\infty}}$ and in particular one can take

C\left(\operatorname{Tot} \operatorname{Var} u_{0},\left\|f^{\prime}\right\|_{L^{\infty}}\right)=\frac{5}{2}\left\|f^{\prime}\right\|_{L^{\infty}} \operatorname{Tot} \operatorname{Var} u_{0}

in formula (1.3). Note furthermore that, in general, we cannot control the left-hand side of (1.3) with TotVar $w_{0}$; see Remark 3.3 for a counterexample and some further considerations. Note furthermore that in section 4.3 we exhibit a counterexample showing that, under the same assumptions as in Theorem 1.1, the total variation of $u(\cdot, x)$, or more precisely of the left and right traces $u\left(\cdot, x^{ \pm}\right)$, can blow up in finite time. However, the next result shows that one can establish a uniform control on the total variation of the entropy admissible solution provided the function $f$ is monotone.

Proposition 1.2. Fix $f \in C^{2}(\mathbb{R})$ and $u_{0} \in B V(\mathbb{R})$. Assume moreover that $f^{\prime} \geq 0$ or $f^{\prime} \leq 0$ on the interval $\left[\operatorname{ess} \inf u_{0}\right.$, ess $\left.\sup u_{0}\right]$. Then the entropy solution of the Cauchy problem (1.1),(1.2) satisfies

\operatorname{Tot} \operatorname{Var} u\left(\cdot, x^{ \pm}\right) \leq \operatorname{Tot} \operatorname{Var} u_{0} \quad \text { for every } x \in \mathbb{R} \tag{1.4}
\end{equation*}

In the above expression, $u\left(\cdot, x^{ \pm}\right)$denote the right and left traces of $u$ at $y=x$.
Note that since $u \in B V(] 0, T[\times \mathbb{R})$ for every $T>0$, then the traces $u\left(\cdot, x^{ \pm}\right)$are well defined owing to the general theory of $B V$ functions; see [5]. Note furthermore that in the statement of Proposition 1.2 we do not impose any concavity or convexity assumption on $f$. Also, the counterexample in section 4.3 shows that the monotonicity assumption in the statement of Proposition 1.2 cannot be dropped, even in the case of a convex flux. Finally, we would like to quote [7, Lemma 4.6], which can be regarded as a discrete version of Proposition 1.2. Note that there are several possible extensions of Theorem 1.1 and Proposition 1.2 to initial-boundary value problems and in the following we will see one of them in Corollary 4.2.
1.2. Applications to a multipath model for traffic flows on road networks. The use of conservation laws in the macroscopic modeling of vehicular and pedestrian traffic started with the works by Lighthill, Whitham, and Richards [35, 40] and has since then flourished: we refer to $[9,13,26]$ for an extended overview. In particular, since the paper by Holden and Risebro [31], several works have been devoted to the study of conservation laws models on road networks. In this framework, one of the main challenges is describing the behavior of the drivers at road junctions; see, for instance, the analysis and the discussion in [14, 18, 26, 31].

In the present work we focus on the multipath approach to a source-destination model for traffic flows on road networks. We refer to $[15,26,28]$ for an extended discussion on source-destination models, but in a nutshell the very basic feature of these models is that drivers are divided into several populations depending on the path they follow on the road network. On each road, the total car density is governed by a scalar conservation law as in the classical Lighthill-Whitham-Richards (LWR) model, whereas the rate of cars following a given path satisfies a transport equation where the coefficient depends on the solution of the conservation law. In [15, 28] the model was approached by relying on wave front-tracking techniques and hence one of the main points in the analyis was the solution of the so-called Riemann problems at road junctions, in the same spirit as in [18, 29]. In particular, in [28] Garavello and Piccoli establish existence of a suitable notion of solution provided the data are a small $B V$ perturbation of an equilibrium and under further technical assumptions. In [15] Bressan and Yu, among other things, exhibit some counterexamples that we comment upon later.

In the present work we focus on the same multipath approach to the sourcedestination model as in [16, 30]. In this approach, one focuses on paths (each of them followed by a population of drivers) rather than on roads. Junctions apparently disappear or, more correctly, are hidden in the fact that the equation governing the evolution of the total car density is discontinuous at each junction. In [16] Briani and Cristiani regard the multipath model as a system of conservation laws with discontinuous fluxes and discuss the theoretical properties of a related Godunov-type numerical scheme. In the present work we approach the multipath model by relying on the theory of transport equations with low regularity coefficients. This allows us to provide a simple and neat formulation of the problem and in particular of the boundary conditions in a very weak $L^{\infty}$ framework. By relying on results obtained in the companion paper [25], we establish existence and uniqueness results for $L^{\infty}$ data under the assumptions that the network only contains T-junctions, that is, junctions with only one incoming road, and that the traffic is not congested. These assumptions are obviously restrictive, but basically necessary to obtain well-posedness in view of a counterexample due to Bressan and Yu [15]. More precisely, [15, Example 3] involves a simple network consisting of two incoming and two outgoing roads where the source-destination model has two distinct solutions, one where the traffic is congested and one where it is not. This shows that uniqueness can be violated if we do not require the condition that the traffic is not congested. In the present work, we focus on a network only containing T-junctions because in this way we obtain that, at every junction, the incoming car flux can be always absorbed by the outgoing roads. This implies that if the traffic is not congested at $t=0$, then it remains not congested and no backward propagating queue is created. See also [27] for another recent work where the authors restrict to T-junctions. We remark in passing that we are very confident that our analysis could be extended to other cases where the condition that the traffic is not congested is propagated and no backward propagating queue is created (one

could think, for instance, of cases where incoming and outgoing roads have different maximal densities). In the present work we also establish propagation of $B V$ regularity and stability, and these results are again interesting in view of counterexamples in [15] that we discuss in the following.

We now provide a detailed description of the multipath approach. To simplify the exposition, we directly focus on the case of a network only containing T-junctions like the one in Figure 1, but this introductory part and Definition 1.3 extend to more general networks. Our network consists of a collection of $h$ roads $I_{1}, \ldots, I_{h}$, each of them parameterized by a bounded interval ${ }^{1}$ and running from a junction point (or from the source) to another (or to a destination). We also work with the $m$ paths $P_{1}, \ldots, P_{m}$ : each of them is a collection of consecutive roads starting from the source and ending in a destination. Very loosely speaking, the basic idea underpinning the model is that on each road the total car density is modeled by the entropy admissible solution of a conservation law as in the classical LWR model. The percentage of cars following a given path is instead described by a transport equation where the coefficient on each road composing the path depends on the total car density on that specific road. The coefficients are therefore fairly irregular (the best regularity one can hope for is $B V$ regularity) and, in particular, the classical method of characteristics does not apply and one has to rely on more advanced techniques to establish wellposedness and other properties.

To discuss the technical details, we fix a time interval $[0, T]$ and for every $i=$ $1, \ldots, h$, we denote by $\rho_{i}$ the total car density on the road $I_{i}$ and as in the classical LWR model we assume that $\rho_{i}$ is an entropy admissible solution of the conservation law

In the previous expression, the velocity function $v$ satisfies

v \in C^{2}(\mathbb{R}), \quad v\left(\rho^{\max }\right)=0, \quad v \geq 0 \text { on }\left[0, \rho^{\max }\right] \tag{1.6}
\end{equation*}
$$

[^1]Here the constant $\rho^{\max }>0$ denotes the maximum possible car density, corresponding to bumper-to-bumper packing. The flux function satisfies

where the density $\rho^{*}<\rho^{\text {max }}$ denotes the transition between free and congested traffic. We remark in passing that we are not making the assumption that $g$ is concave. We denote by $\theta_{1}, \ldots, \theta_{m}$ the traffic-type functions, that is, for every $k=1, \ldots, m$ the function $\theta_{k}$ represents the fraction of cars following the path $P_{k}$. It is governed by the equation

that is, $r_{k}$ is obtained by patching together the $\rho_{i}$ 's. Note that by combining (1.5), (1.8), and (1.9) we formally obtain

which is a transport equation. Note, however, that, in view of the general theory of conservation laws [23], the best regularity one can hope for is $r_{k} \in B V(] 0, T\left[\times P_{k}\right)$ and in this framework the product $v\left(r_{k}\right) \partial_{x} \theta_{k}$ is highly ill defined since in general $\partial_{x} \theta_{k}$ is only a distribution. For every $i=1, \ldots, h$ and $k=1, \ldots, m$, we fix $\rho_{i 0} \in L^{\infty}\left(I_{i}\right)$ and $\theta_{k 0} \in L^{\infty}\left(P_{k}\right)$ and we augment (1.5) and (1.8) with the initial conditions

\end{equation*}

and

\end{equation*}

Since we are focusing on a network only containing T-junctions, all the paths have the same origin $a$ and start with the same road $I_{1}$. We fix $\bar{\rho} \in L^{\infty}(] 0, T[)$ and impose

The above datum is attained in the sense of Bardos, Leroux, and Nédélec [8]; see the discussion in section 2.3. For every $k=1, \ldots, m$, we fix $\bar{\theta}_{k} \in L^{\infty}(\mathbb{R})$ and we impose the boundary condition

The above datum is attained in the sense of the distributional traces as in [20]; see Definition 5.1. To conclude, we recall that $\theta_{k}$ represents the fraction of cars following the path $P_{k}$ and hence the physical range is

We now provide the definition of a distributional solution of the multipath model: we first give the technical definition and then informally discuss some heuristics.

DEFINITION 1.3. For every $i=1, \ldots, h, k=1, \ldots, m$, fix the data $\rho_{i 0} \in L^{\infty}\left(I_{i}\right)$, $\theta_{k 0} \in L^{\infty}\left(P_{k}\right), \bar{\rho}, \bar{\theta}_{k} \in L^{\infty}(] 0, T[)$ and assume that $\bar{\theta}_{k 0}$ and $\bar{\theta}_{k}$ satisfy (1.15) and (1.16), respectively. A distributional solution of the multipath model is a family of functions $\rho_{i} \in L^{\infty}(] 0, T\left[\times I_{i}\right), \theta_{k} \in L^{\infty}(] 0, T\left[\times P_{k}\right), i=1, \ldots, h$, and $k=1, \ldots, m$, such that
(i) for every $i=1, \ldots, h, \rho_{i}$ is an entropy admissible solution of (1.5), (1.11); also, $\rho_{1}$ is an entropy admissible solution of (1.5), (1.11), (1.13), in the sense of [8];
(ii) (1.9) holds true (that is $r_{k}$ is obtained by patching together the $\rho_{i}$ 's);
(iii) $\theta_{k}$ is a distributional solution of the initial-boundary value problem (1.8), (1.12), (1.14), in the sense of Definition 5.1. Also, it satisfies

and

\end{equation*}

a.e. on $] 0, T\left[\times I_{i}\right.$.

Some remarks are here in order. First, in section 2.3 we recall the definition of entropy admissible solution of (1.5), (1.11) and of (1.5), (1.11), (1.13). Second, the heuristic meaning of (1.17) and (1.18) is

but owing to (1.8) $\theta_{k}$ is not uniquely defined on the set where $r_{k}$ vanishes and this is why (1.17) and (1.18) are the correct formulation. Third, providing the formal definition of $(1.8),(1.12),(1.14)$ requires some preliminary considerations (see section 2.5) since the functions $\theta_{k}$ have in general fairly low regularity (they are just $L^{\infty}$ functions) and hence their values at $x=a$, i.e., their values on a negligible set, are a priori not well-defined. However, the heuristic idea is that $\theta_{k}$ is a solution of the transport equation (1.10) satisfying the initial and boundary conditions (1.12) and (1.14). To conclude, we point out that a key property of the source-destination model is the fact that requiring that (1.10) or, more correctly, (1.8) is satisfied on the whole path amounts to imposing flux conservation at junctions; see Lemma 5.2.

We can now state our well-posedness result. We explicitly point out that it is an existence and uniqueness result, whereas several other results concerning traffic models on road networks only establish existence; see, for instance, [18, 27, 28].

THEOREM 1.4. Fix $T>0$ and assume that $v$ and $g$ satisfy (1.6) and (1.7), respectively. For every $i=1, \ldots, h, k=1, \ldots, m$, fix the initial data $\rho_{i 0} \in L^{\infty}\left(I_{i}\right), \theta_{k 0} \in$ $L^{\infty}\left(P_{k}\right)$ and the boundary data $\bar{\rho}, \bar{\theta}_{k} \in L^{\infty}(] 0, T[)$. Assume that $\bar{\theta}_{k 0}$ and $\bar{\theta}_{k}$ satisfy (1.15) and (1.16), respectively, and that $0 \leq \bar{\rho} \leq \rho^{*}, 0 \leq \rho_{i 0} \leq \rho^{*}$. Then there is a distributional solution of the multipath model such that $0 \leq \rho_{i} \leq \rho^{*}$ for every $i=$ $1, \ldots, h$. Also, the solution is unique in the following sense: if $\rho_{1}, \ldots, \rho_{h}, \theta_{1}, \ldots, \theta_{m}$ and $\rho_{1}^{\diamond}, \ldots, \rho_{h}^{\diamond}, \theta_{1}^{\diamond}, \ldots, \theta_{m}^{\diamond}$ are two solutions such that $0 \leq \rho_{i}, \rho_{i}^{\diamond} \leq \rho^{*}$ for every $i=1, \ldots, h$, then

\left.\rho_{i}=\rho_{i}^{\diamond} \text { a.e. on }\right] 0, T\left[\times I_{i} \text { for every } i=1, \ldots, h\right.
$$

and

$$
\begin{equation*}
\left.\rho_{i} \theta_{k}=\rho_{i} \theta_{k}^{\diamond} \text { a.e. on }\right] 0, T\left[\times I_{i} \text { for every } i: I_{i} \subseteq P_{k} \text { and every } k=1, \ldots, m\right. \tag{1.19}
\end{equation*}

Some remarks are again in order. First, the uniqueness result given by Theorem 1.4 is the best one can hope for since, as pointed out before, (1.8) does not provide any information on $\theta_{k}$ on the set where $r_{k}$ vanishes. Second, as mentioned before, Lemma 5.2 states that distributional solutions of the multipath model satisfy flux conservation at junctions. However, it is well-known that the flux conservation does not suffice to select a unique solution; see the discussion in [26]. The requirement that $0 \leq \rho_{i} \leq \rho^{*}$, i.e., that the traffic is not congested, can therefore be viewed as an admissibility criterion, which is reasonable in our framework: since the network only contains T-junctions, if the traffic is not congested at the initial time and at the source, one expects that it never gets congested. The next result establishes propagation of $B V$ regularity.

THEOREM 1.5. Under the same assumptions as in the statement of Theorem 1.4, assume furthermore that, for every $i=1, \ldots, h$ and $k=1, \ldots, m, \rho_{i 0} \in B V\left(I_{i}\right), \theta_{k 0} \in$ $B V\left(P_{k}\right), \bar{\rho}, \bar{\theta}_{k} \in B V(] 0, T[)$. Also, assume that, for some constant $\varepsilon>0$,

\varepsilon \leq \rho_{i 0}, \bar{\rho} \leq \rho^{*}-\varepsilon, \quad \varepsilon \leq \theta_{k 0}, \bar{\theta}_{k} \leq 1, \quad \text { for every } i=1, \ldots, h \text { and } k=1, \ldots, m
$$

Then the distributional solution $\rho_{1}, \ldots, \rho_{h}, \theta_{1}, \ldots, \theta_{m}$ of the source destination model satisfies $\rho_{i} \in B V(] 0, T\left[\times I_{i}\right)$ and $\theta_{k} \in B V(] 0, T\left[\times P_{k}\right)$ for every $i=1, \ldots, h$ and $k=1, \ldots, m$.

Note that, under the assumptions of Theorem 1.5, $r_{k}$ is bounded away from 0 and hence the function $\theta_{k}$ is uniquely determined in view of the uniqueness result given in Theorem 1.4. Also, by carefully tracking the proof one could establish, if needed, an explicit bound on the total variation of $\rho_{i}$ and $\theta_{k}, i=1, \ldots, h, k=1, \ldots, m$, in terms of the total variation of the data and $\varepsilon$. In particular, on the road $I_{1}$ one has

In the previous expression, $\theta_{k 0}\left(a^{+}\right)$and $\bar{\theta}_{k}\left(0^{+}\right)$denote the right limits of the functions $\theta_{k 0}$ and $\bar{\theta}_{k}$ at $x=a$ and $t=0$, respectively. They exist because the functions have bounded total variation. The explicit estimates on the total variation on the roads $I_{2}, \ldots, I_{h}$ have a fairly involved expression which we do not report here. We stress, however, that contrary to (1.20), these estimates depend on the parameter $\varepsilon$ and their right-hand side blows up when $\varepsilon \rightarrow 0^{+}$.

Finally, it is interesting to compare Theorem 1.5 with a counterexample in [15]. More precisely, [15, Example 4] shows that, on a general network and for initial densities that attain the value 0 , one can have finite time blow-up of the total variation even if the data have arbitrarily small total variation. To conclude, we establish the $L^{1}$-stability of the distributional solutions of the source-destination model with respect to perturbations in the data.

Corollary 1.6. Fix $T>0$ and assume that $v$ and $g$ satisfy (1.6) and (1.7), respectively. For every $i=1, \ldots, h, k=1, \ldots, m$, fix some sequences of initial data $\left\{\rho_{i 0}^{n}\right\}_{n \in \mathbb{N}} \subseteq L^{\infty}\left(I_{i}\right),\left\{\theta_{k 0}^{n}\right\}_{n \in \mathbb{N}} \subseteq L^{\infty}\left(P_{k}\right)$ and of boundary data $\left\{\bar{\rho}^{n}\right\}_{n \in \mathbb{N}},\left\{\bar{\theta}_{k}^{n}\right\}_{n \in \mathbb{N}} \subseteq$ $L^{\infty}(] 0, T[)$ in such a way that, for every $n, 0 \leq \rho_{i 0}^{n} \leq \rho^{*}, 0 \leq \bar{\rho}^{n} \leq \rho^{*}$ and (1.15) and (1.16) are satisfied. Also, assume that (1.21)
$\rho_{i 0}^{n} \rightarrow \rho_{i 0}$ in $L^{1}\left(I_{i}\right), \theta_{k 0}^{n} \rightarrow \theta_{k 0}$ in $L^{1}\left(P_{k}\right), \bar{\rho}^{n} \rightarrow \bar{\rho}$ in $L^{1}(] 0, T[), \bar{\theta}_{k}^{n} \rightarrow \bar{\theta}_{k}$ in $L^{1}(] 0, T[)$
for every $i=1, \ldots, h, k=1, \ldots, m$, as $n \rightarrow+\infty$. Let $\left\{\rho_{i}^{n}, \theta_{k}^{n}\right\}_{n \in \mathbb{N}}$ denote a sequence of distributional solutions of the source-destination model with data $\rho_{i 0}^{n}, \theta_{k 0}^{n}, \bar{\rho}^{n}, \bar{\theta}_{k}^{n}$, $i=1, \ldots, h, k=1, \ldots, m$. Then

& \text { for every } i=1, \ldots, h \text { and } k=1, \ldots, m .

In the previous expression, $\rho_{1}, \ldots, \rho_{h}, \theta_{1}, \ldots, \theta_{m}$ is the distributional solution of the source-destination model with data $\rho_{i 0}, \theta_{k 0}, \bar{\rho}, \bar{\theta}_{k}, i=1, \ldots, h, k=1, \ldots, m$, and $r_{k}^{n}$, $r_{k}$ are obtained by patching together the $\rho_{i}^{n}$ 's and the $\rho_{i}$ 's, respectively; see (1.9).

Again, it is interesting to compare Corollary 1.6 with a counterexample by Bressan and Yu. More precisely, Example 5 in [15] is concerned with a simple network consisting of a single T-junction with an incoming road and two outgoing roads and exhibits instability with respect to the weak* convergence. Note, however, that a key point in the construction of [15, Example 5] is that the flux function in the incoming and outgoing roads is not the same, whereas here we are assuming that it is the same on every road. The source of instability in [15, Example 5] is the highly oscillatory behavior of the functions $\theta_{k}$ at $t=0$, which in the statement of Corollary 1.6 is ruled out by strong convergence.

Outline. The exposition is organized as follows. In section 2 we review some previous results that we need in the following. In section 3 we provide the proof of Theorem 1.1. In section 4 we establish the proof of Proposition 1.2 and of Corollary 4.2 and we discuss the example of total variation blow-up. In section 5 we complete the distributional formulation of the source-destination model and we establish the proof of Theorem 1.4. In section 6 we give the proofs of Theorem 1.5 and Corollary 1.6.

Notation. For the reader's convenience, we collect here the main notation used in the present paper. We denote by $C\left(a_{1}, \ldots, a_{\ell}\right)$ a constant only depending on the quantities $a_{1}, \ldots, a_{\ell}$. Its precise value can vary from occurrence to occurrence.

- a.e., for a.e.: almost everywhere, for almost every. Unless otherwise specified, it means with respect to the standard Lebesgue measure;
- $B V$ : the space of bounded variation functions;
- TotVar $u$ : the total variation of the function $u$;
- $u\left(\cdot, x^{ \pm}\right)$: the left and right traces of the function $u \in B V(] 0, T[\times \mathbb{R})$ at $y=x$, which are well defined owing to the general theory of $B V$ functions (see [5]);
- $u_{\alpha}, u_{\beta}$, also denoted by $u\left(\cdot, \alpha^{+}\right), u\left(\cdot, \beta^{-}\right)$: the strong traces given by Theorem 2.4;

2. Overview of previous results. In this section we collect some previous results that we need in the following.
2.1. A regularity result for zero-divergence vector fields. We quote a very special case of Lemma 1.3.3 in [23].

Lemma 2.1. Fix two (finite or infinite) intervals $] 0, T[] a,, b[\subseteq \mathbb{R}$. Assume that $u, z \in L^{\infty}(] 0, T[\times] a, b[)$ satisfy $\partial_{t} u+\partial_{x} z=0$ in the sense of distributions on $] 0, T[\times] a, b[$. Then $u$ has a representative such that the map $] 0, T\left[\rightarrow L^{\infty}(] a, b[), t \mapsto u(t, \cdot)\right.$ is continuous with respect to the weak* topology. Also, z has a representative such that the map $] a, b\left[\rightarrow L^{\infty}(] 0, T[), x \mapsto z(\cdot, x)\right.$ is continuous with respect to the weak topology.

Remark 2.2. In the following, we always use the continuous representative of the maps $t \mapsto u(t, \cdot)$ and $x \mapsto z(\cdot, x)$. In this way, the values $u(t, \cdot)$ and $z(\cdot, x)$ are well defined for every $t$ and $x$, respectively.
2.2. Continuity of traces. By combining [5, Theorem 3.88] with the observation that translations are continuous with respect to the strict convergence in $B V$ we get the following result.

Lemma 2.3. Fix $T>0$, assume that $u \in L^{\infty} \cap B V(] 0, T[\times \mathbb{R})$ and fix a sequence $\left\{x_{n}\right\}_{n \in \mathbb{N}} \subseteq \mathbb{R}, x_{n} \leq \bar{x}$ such that $x_{n} \uparrow \bar{x} \in \mathbb{R}$ as $n \rightarrow+\infty$. Then $u\left(\cdot, x_{n}^{ \pm}\right)$converges in $L^{1}(] 0, T[)$ to $u\left(\cdot, \bar{x}^{-}\right)$. If $x_{n} \geq \bar{x}$ and $x_{n} \downarrow \bar{x}$, then $u\left(\cdot, x_{n}^{ \pm}\right)$converges in $L^{1}(] 0, T[)$ to $u\left(\cdot, \bar{x}^{+}\right)$.
2.3. Entropy admissible solutions of initial-boundary value problems for scalar conservation laws. We now discuss the definition of entropy admissible solution of the initial-boundary value problem obtained augmenting the conservation law (1.1) with the initial and boundary conditions

We restrict to the one-dimensional case because it is the one we need in the following; however, several results we quote extend to the multidimensional setting. See the book by Serre [43] for a general discussion on initial-boundary value problems for conservation laws. We first quote (a particular case of) a result due to Kwon and Vasseur [34, Theorem 1] and Panov [39, Theorem 1.1].

Theorem 2.4. Fix $T>0$, a bounded interval $] \alpha, \beta[\subseteq \mathbb{R}$, and a flux function $f \in C^{2}(\mathbb{R})$. Assume that $u \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ satisfies

\end{equation*}

for $h(u):=f(u)$ and $h(u):=\operatorname{sign}(u-c)[f(u)-f(c)], c \in \mathbb{R}$.

In the following we will refer to $f\left(u_{\alpha}\right)$ and $f\left(u_{\beta}\right)$ as the strong traces of $f(u)$; see also Remark 2.12. Also, we will sometimes denote them by $f(u)\left(\cdot, \alpha^{+}\right)$and $f(u)\left(\cdot, \beta^{-}\right)$, respectively. Note that in the previous result the regularity of $u$ is only $u \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ and that in general one cannot replace $h$ with the identity in (2.3). However, this is instead possible if $u \in B V(] \alpha, \beta[\times] 0, T[)$ owing to the general theory of $B V$ functions (see [5]) or when $f^{\prime \prime}>0$ or $f^{\prime \prime}<0$ (see [44]).

Definition 2.5. Fix $f \in C^{2}(\mathbb{R}), \alpha, \beta \in \mathbb{R}, T>0, \bar{u}, \underline{u} \in L^{\infty}(] 0, T[)$, and $u_{0} \in$ $L^{\infty}(] \alpha, \beta[)$. We say that $u \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ is an entropy admissible solution of the initial-boundary value problem (1.1), (2.1) if

& +\int_{0}^{T} \varphi(\cdot, \alpha) \operatorname{sign}(\bar{u}-c)\left[f\left(u_{\alpha}\right)-f(c)\right] d t-\int_{0}^{T} \varphi(\cdot, \beta) \operatorname{sign}(\underline{u}-c)\left[f\left(u_{\beta}\right)-f(c)\right] d t \geq 0
\end{align*}

for every $c \in \mathbb{R}$ and $\varphi \in C_{c}^{\infty}(]-\infty, T[\times \mathbb{R})$ such that $\varphi \geq 0$.
The above definition should be interpreted in the following sense: if (2.4) holds true, then in particular (2.2) is satisfied, and hence by Theorem 2.4 the values $f\left(u_{\alpha}\right)$ and $f\left(u_{\beta}\right)$ are well defined and satisfy (2.3). Note that an alternative approach to provide a definition of entropy admissible solution of (1.1), (2.1) is discussed by Otto [38]. See also the discussion in [41].

The analysis in [8] combined with Theorem 2.4 yields existence and uniqueness results for the entropy admissible solution of (1.1), (2.1). Also, the entropy admissible solution satisfies the maximum principle: if $\kappa \leq \bar{u}, \underline{u}, u_{0} \leq K$ a.e. for some constants $\kappa, K \in \mathbb{R}$, then

Also, if $\bar{u}, \underline{u} \in B V(] 0, T[)$ and $u_{0} \in B V(] \alpha, \beta[)$, then
$\operatorname{Tot} \operatorname{Var} u(t, \cdot) \leq \operatorname{Tot} \operatorname{Var} u_{0}+\operatorname{TotVar} \bar{u}+\operatorname{TotVar} \underline{u}+\left|u_{0}\left(\alpha^{+}\right)-\bar{u}\left(0^{+}\right)\right|+\left|u_{0}\left(\beta^{-}\right)-\underline{u}\left(0^{+}\right)\right|$ for every $t>0$. In the previous expression, $u_{0}\left(\alpha^{+}\right)$and $u_{0}\left(\beta^{-}\right)$denote the right limit of the function $u_{0}$ at $x=\alpha$ and the left limit at $x=\beta$, respectively. They are well defined since $u_{0} \in B V(] \alpha, \beta[)$. We now focus on the case $f^{\prime} \geq 0$, then to obtain a well-posed problem it suffices to assign the data at $t=0$ and $x=\alpha$, that is,

More precisely, we have the following.
Proposition 2.6. Fix $T>0$, a bounded interval $] \alpha, \beta[\subseteq \mathbb{R}$, and a flux function $f \in C^{2}(\mathbb{R})$. Assume furthermore that $f^{\prime} \geq 0$ on $\left[\min \left\{\operatorname{ess} \inf \bar{u}\right.\right.$, ess inf $\left.u_{0}\right\}$, $\left.\max \left\{\operatorname{ess} \sup \bar{u}, \operatorname{ess} \sup u_{0}\right\}\right]$. Then there is a unique entropy admissible solution of the initial-boundary value problem (1.1), (2.6) such that $f^{\prime}(u) \geq 0$ a.e. on $] 0, T[\times] \alpha, \beta[$. In other words, there is a unique function $\left.u \in L^{\infty}(] 0, T[\times] \alpha, \beta\right)$ such that $f^{\prime}(u) \geq 0$ and

for every $c \in \mathbb{R}$ and $\varphi \in C_{c}^{\infty}(]-\infty, T[\times]-\infty, \beta[)$ such that $\varphi \geq 0$.

Note that, under the same assumptions as in Proposition 2.6, if $\bar{u} \in B V(] 0, T[)$ and $u_{0} \in B V(] \alpha, \beta[)$, then
(2.8) $\operatorname{Tot} \operatorname{Var} u(t, \cdot) \leq \operatorname{Tot} \operatorname{Var} u_{0}+\operatorname{Tot} \operatorname{Var} \bar{u}+\left|u_{0}\left(\alpha^{+}\right)-\bar{u}\left(0^{+}\right)\right| \quad$ for every $t \geq 0$.

The following result is well known and we provide the proof for the sake of completeness.

Proposition 2.7. Fix $T>0$, a bounded interval $] \alpha, \beta[\subseteq \mathbb{R}$, and a flux function $f \in C^{2}(\mathbb{R})$. Assume furthermore that $f^{\prime}>0$ on $\left[\min \left\{\operatorname{ess} \inf \bar{u}\right.\right.$, $\left.\operatorname{ess} \inf u_{0}\right\}$, $\left.\max \left\{\operatorname{ess} \sup \bar{u}, \operatorname{ess} \sup u_{0}\right\}\right]$ and that $u \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ satisfies (2.7). Then $u_{\alpha}=$ $\bar{u}$ a.e. on $] 0, T$.

Proof. We fix $\lambda \in C_{c}^{\infty}(] 0, T[)$ and a family of functions $\omega_{\varepsilon} \in C_{c}^{\infty}(\mathbb{R})$ such that (2.9)
$\omega_{\varepsilon}(x)=1$ if $\alpha-1<x<\alpha+\varepsilon, \omega_{\varepsilon}(x)=0$ if $x>\alpha+2 \varepsilon, \quad \omega_{\varepsilon}^{\prime}(x) \leq 0$ for every $\left.x \in\right] \alpha-1,+\infty[$.
We plug the test function $\varphi_{\varepsilon}(t, x):=\lambda(t) \omega_{\varepsilon}(x)$ into (2.7) and let $\varepsilon \rightarrow 0^{+}$. By relying on Lemma 2.4 we obtain

and by the arbitrariness of $\lambda$ this implies that $\left[\operatorname{sign}(\bar{u}-c)-\operatorname{sign}\left(u_{\alpha}-c\right)\right]\left[f\left(u_{\alpha}\right)-f(c)\right] \geq$ 0 a.e. on $] 0, T\left[\right.$. By relying on a case-by-case analysis we can then conclude that $u_{\alpha}=\bar{u}$ a.e. on $] 0, T$ [.

In the following we also need the next result and again we provide a sketch of the proof for the sake of completeness.

Lemma 2.8. Under the same assumptions as in the statement of Proposition 2.6, assume that $\left\{u_{0 n}\right\} \subseteq L^{\infty}(] \alpha, \beta[)$ and $\left\{\bar{u}_{n}\right\} \subseteq L^{\infty}(] 0, T[)$ are two sequences of initial and boundary data such that

\left.f^{\prime}\left(u_{0 n}\right) \geq 0 \quad \text { a.e. on }\right] \alpha, \beta\left[, \quad f^{\prime}\left(\bar{u}_{n}\right) \geq 0 \quad \text { a.e. on }\right] 0, T[\text {, for every } n \in \mathbb{N}
$$

and

\begin{equation*}
u_{0 n} \rightarrow u_{0} \quad \text { in } L^{1}(] \alpha, \beta[), \quad \bar{u}_{n} \rightarrow \bar{u} \quad \text { in } L^{1}(] 0, T[) . \tag{2.10}
\end{equation*}
$$

Let $\left\{f\left(u_{\beta n}\right)\right\}$ be the sequences of the traces of the fluxes as in Theorem 2.4; then $f\left(u_{\beta n}\right)$ converges to $f\left(u_{\beta}\right)$ in $L^{1}(] 0, T[)$.

Sketch of the proof of Lemma 2.8. Let $u$ be the entropy admissible solution of the initial-boundary value problem (1.1), (2.6). By relying on (2.7) and on a suitable choice of the test functions (in the same spirit as the one in the proof of Proposition 2.7) and by recalling Theorem 2.4 we arrive at

& \quad \leq \int_{\alpha}^{\beta}\left|u_{0}-c\right| d x+2 \int_{0}^{T}\left|f\left(u_{\alpha}\right)-f(c)\right| d t .
\end{aligned}

By using the celebrated doubling of variables method by Kružkov [33] and recalling that, by the same argument as in Proposition 2.7, $f\left(u_{\alpha}\right)=f(\bar{u}), f\left(u_{\alpha n}\right)=f\left(\bar{u}_{n}\right)$ we arrive at

By relying on the proof of Lemma 2.8 we also get the following result.
Lemma 2.9. Fix $T>0$, a bounded interval $] \alpha, \beta[\subseteq \mathbb{R}$, and a flux function $f \in$ $C^{2}(\mathbb{R})$. Assume that $u, v \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ are two entropy admissible solutions in the sense of Definition 2.5 and satisfy the inequality $f^{\prime} \geq 0$ a.e. on $[\min \{\operatorname{ess} \inf v, \operatorname{ess} \inf u\}, \max \{\operatorname{ess} \sup v, \operatorname{ess} \sup u\}]$. Assume that $u_{0}=v_{0}$ and $f(\bar{u})=$ $f(\bar{v})$; then $u=v$ a.e. on $] 0, T[\times] \alpha, \beta[$.

To conclude, we assign the initial condition

$$
\begin{equation*}
u(0, \cdot)=u_{0} \tag{2.11}
\end{equation*}
$$

and, since for technical reasons we need it in the following, we give the definition of entropy admissible solution of (1.1), (2.11).

Definition 2.10. Fix $T>0$, an interval $] \alpha, \beta[\subseteq \mathbb{R}$, and a flux function $f \in$ $C^{2}(\mathbb{R})$. We say that $u \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ is an entropy admissible solution of (1.1), (2.11) if

$$
\begin{equation*}
\int_{0}^{T} \int_{\alpha}^{\beta} \partial_{t} \psi|u-c|+\partial_{x} \psi \operatorname{sign}(u-c)[f(u)-f(c)] d x d t+\int_{\alpha}^{\beta} \psi(0, \cdot)\left|u_{0}-c\right| d x \geq 0 \tag{2.12}
\end{equation*}
$$

for every $\psi \in C_{c}^{\infty}(]-\infty, T[\times] \alpha, \beta[)$ such that $\psi \geq 0$ and $c \in \mathbb{R}$.
Needless to say, unless $] \alpha, \beta[=\mathbb{R}$, in general we do not expect that the entropy admissible solution of (1.1), (2.11) is unique because we are not prescribing any boundary condition.
2.4. Distributional traces for solutions of continuity equations. In the following we quote a result that will enable us to give a meaning to the boundary condition in (1.14). We refer to $[3,6,17]$ for a general discussion about normal traces for measure divergence vector fields. We now state a straighforward corollary of [20, Lemma 3.3].

Lemma 2.11. Fix $\alpha, \beta \in \mathbb{R}, T>0$. Assume that $r, b, \theta \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ satisfy

$$
\begin{equation*}
\int_{0}^{T} \int_{\alpha}^{\beta} r \theta\left(\partial_{t} \phi+b \partial_{x} \phi\right) d x d t=0 \quad \text { for every } \phi \in C_{c}^{\infty}(] 0, T[\times] \alpha, \beta[) . \tag{2.13}
\end{equation*}
$$

Then there are unique functions $\operatorname{Tr}[b r \theta]\left(\cdot, \alpha^{+}\right), \operatorname{Tr}[b r \theta]\left(\cdot, \beta^{-}\right) \in L^{\infty}\left(\mathbb{R}_{+}\right)$, and $[r \theta]_{0} \in$ $L^{\infty}(] \alpha, \beta[)$ such that

$$
\begin{align*}
\int_{0}^{T} \int_{\alpha}^{\beta} r \theta\left(\partial_{t} \varphi+b \partial_{x} \varphi\right) d x d t= & \int_{0}^{T} \varphi \operatorname{Tr}[b r \theta]\left(\cdot, \alpha^{+}\right) d t+\int_{0}^{T} \varphi \operatorname{Tr}[b r \theta]\left(\cdot, \beta^{-}\right) d t  \tag{2.14}\\
& -\int_{\alpha}^{\beta}[r \theta]_{0} \varphi(0, \cdot) d x, \quad \text { for every } \varphi \in C_{c}^{\infty}(]-\infty, T[\times \mathbb{R}) .
\end{align*}
$$

Proof. We apply [20, Lemma 3.3] with $w=r \theta$ and $b$ in [20, Lemma 3.3] given by $b r \theta$ in here and we point out that to establish [20, formula (3.6)] we do not use the assumption that $\operatorname{div} b$ is a finite Radon measure.

Remark 2.12. From now on we refer to $\operatorname{Tr}[b r \theta]\left(\cdot, \alpha^{+}\right)$and $\operatorname{Tr}[b r \theta]\left(\cdot, \beta^{-}\right)$as distributional traces, whereas we refer to the functions $f\left(u_{\alpha}\right), f\left(u_{\beta}\right)$ given by Theorem 2.4 as strong traces. The reason is the following: the functions $f\left(u_{\alpha}\right), f\left(u_{\beta}\right)$ are strong traces in the sense that they are attained as strong limits in the $L^{1}$ topology, whereas $\operatorname{Tr}[b r \theta]\left(\cdot, \alpha^{+}\right)$and $\operatorname{Tr}[b r \theta]\left(\cdot, \beta^{-}\right)$are distributional traces and in general they are only attained as limits in the weak* topology; see the discussion in [3]. Also, we recall that in the following we will sometimes denote $f\left(u_{\alpha}\right)$ and $f\left(u_{\beta}\right)$ by $f(u)\left(\cdot, \alpha^{+}\right)$and $f(u)\left(\cdot, \beta^{-}\right)$, respectively.

The next result asserts that the two notions of traces coincide when they are both defined.

Lemma 2.13. Fix $\alpha, \beta \in \mathbb{R}, T>0, v \in C^{1}(\mathbb{R})$ and assume that $\rho_{i} \in L^{\infty}$ ( $] 0, T[\times] \alpha, \beta[)$ satisfies (2.2) with $u=\rho_{i}, f\left(\rho_{i}\right)=v\left(\rho_{i}\right) \rho_{i}$; then

$$
\begin{equation*}
v\left(\rho_{i}\right) \rho_{i}\left(\cdot, \alpha^{+}\right)=-\operatorname{Tr}\left[v\left(\rho_{i}\right) \rho_{i}\right]\left(\cdot, \alpha^{+}\right), \quad v\left(\rho_{i}\right) \rho_{i}\left(\cdot, \beta^{-}\right)=\operatorname{Tr}\left[v\left(\rho_{i}\right) \rho_{i}\right]\left(\cdot, \beta^{-}\right) \tag{2.15}
\end{equation*}
$$

Note that the distributional traces $\operatorname{Tr}\left[v\left(\rho_{i}\right) \rho_{i}\right]\left(\cdot, \alpha^{+}\right)$and $\operatorname{Tr}\left[v\left(\rho_{i}\right) \rho_{i}\right]\left(\cdot, \beta^{-}\right)$are well defined since by choosing $c<-\left\|\rho_{i}\right\|_{L^{\infty}}$ and $c>\left\|\rho_{i}\right\|_{L^{\infty}}$ we deduce from (2.2) that $r=\rho_{i}$ satisfies (2.13) with $\theta=1$ and $b=v\left(\rho_{i}\right)$ and hence we can apply Lemma 2.11.

Proof of Lemma 2.13. We fix $\varphi \in C^{\infty}(] 0, T[\times \mathbb{R})$ and consider the family of test functions $\phi_{\varepsilon}(t, x):=\varphi(t, x)\left[1-\omega_{\varepsilon}(x)\right]\left[1-\omega_{\varepsilon}(\alpha+\beta-x)\right]$, where $\omega_{\varepsilon}$ is the same as in (2.9). We plug $\phi_{\varepsilon}$ into (2.13) where $r=\rho_{i}, \theta=1$, and $b=v\left(\rho_{i}\right)$ and then let $\varepsilon \rightarrow 0^{+}$. By using (2.3) we arrive at

$$
\int_{0}^{T} \int_{\alpha}^{\beta} \rho_{i}\left(\partial_{t} \varphi+v\left(\rho_{i}\right) \partial_{x} \varphi\right) d x d t=-\int_{0}^{T} \varphi v\left(\rho_{i}\right) \rho_{i}\left(\cdot, \alpha^{+}\right) d t+\int_{0}^{T} \varphi v\left(\rho_{i}\right) \rho_{i}\left(\cdot, \beta^{-}\right) d t
$$

and by the arbitrariness of $\varphi$ this yields (2.15).
The following result is well known and we provide the proof for the sake of completeness.

Lemma 2.14. Under the same assumptions as in Lemma 2.11, let $d \in] \alpha, \beta[$. Then

$$
\begin{equation*}
\operatorname{Tr}[b r \theta]\left(\cdot, d^{+}\right)=-\operatorname{Tr}[b r \theta]\left(\cdot, d^{-}\right) \tag{2.16}
\end{equation*}
$$

In the above formula the functions $\operatorname{Tr}[b r \theta]\left(\cdot, d^{+}\right)$and $\operatorname{Tr}[b r \theta]\left(\cdot, d^{-}\right)$are obtained by applying Lemma 2.11 to the intervals $] d, \beta[$ and $] \alpha, d[$, respectively.

Proof. We fix $\varphi \in C_{c}^{\infty}(]-\infty, T[\times \mathbb{R})$; then
$\int_{0}^{T} \int_{\alpha}^{d} r \theta\left(\partial_{t} \varphi+b \partial_{x} \varphi\right) d x d t=\int_{0}^{T} \varphi \operatorname{Tr}[b r \theta]\left(\cdot, \alpha^{+}\right) d t+\int_{0}^{T} \varphi \operatorname{Tr}[b r \theta]\left(\cdot, d^{-}\right) d t-\int_{\alpha}^{d}[r \theta]_{0} \varphi(0, \cdot) d x$
and
$\int_{0}^{T} \int_{d}^{\beta} r \theta\left(\partial_{t} \varphi+b \partial_{x} \varphi\right) d x d t=\int_{0}^{T} \varphi \operatorname{Tr}[b r \theta]\left(\cdot, d^{+}\right) d t+\int_{0}^{T} \varphi \operatorname{Tr}[b r \theta]\left(\cdot, \beta^{-}\right) d t-\int_{d}^{\beta}[r \theta]_{0} \varphi(0, \cdot) d x$.
By adding the above expressions, recalling (2.14), and using the arbitrariness of the test function $\varphi$ we arrive at (2.16).
2.5. Well-posedness of the initial-boundary value problem for nearly incompressible vector fields in one space dimension. We now quote some results from [25] we need in the following. We first recall that $b \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ is a nearly incompressible vector field if there is a function $\rho \in L^{\infty}(] 0, T[\times] \alpha, \beta[), \rho \geq 0$, such that $\partial_{t} \rho+\partial_{x}[b \rho]=0$. We refer to [24] for an extended discussion on (possibly multidimensional) nearly incompressible vector fields. We assume that $b \geq 0$ and consider the initial-boundary value problem

$$
\left\{\begin{array}{l}
\partial_{t}[\rho \theta]+\partial_{x}[b \rho \theta]=0,  \tag{2.17}\\
\theta(0, \cdot)=\theta_{0}, \quad \theta(\cdot, \alpha)=\bar{\theta},
\end{array}\right.
$$

where the boundary condition is attained in the sense of [25, Definition 2.7], that is, by requiring that

$$
\begin{equation*}
\operatorname{Tr}[b \rho \theta]\left(\cdot, \alpha^{+}\right)=\bar{\theta} \operatorname{Tr}[b \rho]\left(\cdot, \alpha^{+}\right) \tag{2.18}
\end{equation*}
$$

The above distributional traces are well defined owing to Lemma 2.11; see also the discussion in [25, section 2.3]. By combining Theorem 1.2, Corollary 1.3, and Remark 6.2 in [25] we arrive at the following result.

Theorem 2.15. Fix $T>0$ and a bounded from below interval $] \alpha, \beta[\subseteq \mathbb{R}$. Let $b \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ be a nearly incompressible vector field with density $\rho$ and assume furthermore that $b \geq 0$. For every $\theta_{0} \in L^{\infty}(] \alpha, \beta[)$ and $\bar{\theta} \in L^{\infty}(] 0, T[)$ there is a distributional solution $\theta \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ of the initial-boundary value problem (2.17) satisfying

$$
\begin{equation*}
\|\theta\|_{L^{\infty}} \leq \max \left\{\left\|\theta_{0}\right\|_{L^{\infty}},\|\bar{\theta}\|_{L^{\infty}}\right\} . \tag{2.19}
\end{equation*}
$$

Also, the solution is unique in the following sense: if $\theta_{a}, \theta_{b} \in L^{\infty}(] 0, T[\times] \alpha, \beta[)$ are two different solutions, then $\rho \theta_{a}=\rho \theta_{b}$ a.e. on $] \alpha, \beta[\times] 0, T[$. Finally, we have $a$ comparison principle: if $\theta_{01} \geq \theta_{02}$ and $\bar{\theta}_{1} \geq \bar{\theta}_{2}$, then the corresponding solutions satisfy $\rho \theta_{1} \geq \rho \theta_{2}$ a.e. on $] \alpha, \beta[\times] 0, T[$.

Note that the uniqueness result in Theorem 2.15 is the best one can hope for since the equation at the first line of $(2.17)$ does not provide any information on $\theta$ on the set where $\rho$ vanishes. Concerning the regularity of the solution, by combining Proposition 1.4 and Theorem 1.5 in [25] we get the following result.

THEOREM 2.16. Under the same assumptions as in the statement of Theorem 2.15, assume furthermore that $\bar{\theta} \in B V(] 0, T[)$ and $\theta_{0} \in B V(] \alpha, \beta[)$. Then there is a solution $\theta$ of (2.17) such that $\theta \in B V(] 0, T[\times] \alpha, \beta[)$ and

$$
\left.\operatorname{Tot} \operatorname{Var} \theta(t, \cdot) \leq \operatorname{Tot} \operatorname{Var} \bar{\theta}+\operatorname{Tot} \operatorname{Var} \theta_{0}+\left|\theta_{0}\left(\alpha^{+}\right)-\bar{\theta}\left(0^{+}\right)\right| \quad \text { for a.e. } t \in\right] 0, T[.
$$

Also, for every $x \in] \alpha, \beta]$ there is $\tilde{\theta}_{x} \in L^{\infty}(] 0, T[)$ such that

$$
\begin{aligned}
\operatorname{Tr}[b \rho \theta](\cdot, x) & \left.=\operatorname{Tr}[b \rho](\cdot, x) \tilde{\theta}_{x} \text { a.e. on }\right] 0, T[ \\
\operatorname{Tot} \operatorname{Var} \tilde{\theta}_{x} & \leq C\left(\operatorname{Tot} \operatorname{Var} \theta_{0}, \operatorname{Tot} \operatorname{Var} \bar{\theta},\left|\theta_{0}\left(\alpha^{+}\right)-\bar{\theta}\left(0^{+}\right)\right|\right)
\end{aligned}
$$

In the above expression, $\theta_{0}\left(\alpha^{+}\right)$and $\bar{\theta}\left(0^{+}\right)$denote the right limits of the functions $\theta_{0}$ and $\bar{\theta}$ at $x=\alpha$ and $t=0$, respectively. They are well defined because the functions are of bounded total variation by assumption.
3. Proof of Theorem 1.1. We now provide the proof of Theorem 1.1. Throughout the proof, we denote by $u$ the entropy admissible solution of the Cauchy problem (1.1), (1.2) and use the notation $w=f \circ u$. The exposition is organized as follows. In section 3.1 we establish some preliminary results and in section 3.2 we complete the proof. We always focus on the case $f^{\prime \prime} \leq 0$. The case $f^{\prime \prime} \geq 0$ follows by recalling that if $u$ satisfies (1.1), then $z(t, x):=u(t,-x)$ satisfies

$$
\partial_{t} z+\partial_{x}[-f(z)]=0
$$

Also, without loss of regularity we can assume that $f^{\prime \prime}<0$. The general case $f^{\prime \prime} \leq 0$ can be recovered by considering the sequence $f_{\varepsilon}(u):=f(u)-\varepsilon u^{2}$ and then passing to the $\varepsilon \rightarrow 0^{+}$limit by arguing as in Step 3D of section 3.2.

### 3.1. Preliminary results.

Lemma 3.1. Assume that $\gamma:] t_{1}, t_{2}\left[\rightarrow \mathbb{R}\right.$ is a $C^{1}$ curve across which $u$ is discontinuous. Fix $\tau \in] t_{1}, t_{2}[$ and assume that there is a neighborhood $\mathcal{U}$ of $(\tau, \gamma(\tau))$ such that there are continuous extensions of the entropy admissible solution $u$ to $\mathcal{U} \cap\{(t, x): x \leq \gamma(t)\}$ and $\mathcal{U} \cap\{(t, x): x \geq \gamma(t)\}$. If $\gamma^{\prime}(\tau) \neq 0$, then

$$
\begin{equation*}
\lim _{t \rightarrow \tau^{+}} w(t, \gamma(\tau)) \leq \lim _{t \rightarrow \tau^{-}} w(t, \gamma(\tau)) \quad \text { provided } w:=f \circ u \tag{3.1}
\end{equation*}
$$

and, in particular, the above limits are well defined. If $\gamma^{\prime}(\tau)=0$, then $w$ is continuous at $(\tau, \gamma(\tau))$.

We point out that, by assumption, $\tau$ is neither the starting nor the final point of the curve $\gamma$.

Proof of Lemma 3.1. We set

$$
u^{-}:=\lim _{x \rightarrow \gamma(\tau)^{-}} u(t, x), \quad u^{+}:=\lim _{x \rightarrow \gamma(\tau)^{+}} u(t, x)
$$

and note that the above limits exist since $u(\tau, \cdot) \in B V(\mathbb{R})$. The Rankine-Hugoniot condition gives

$$
\begin{equation*}
f\left(u^{+}\right)-f\left(u^{-}\right)=\gamma^{\prime}(\tau)\left[u^{+}-u^{-}\right] \tag{3.2}
\end{equation*}
$$

Also, the Lax admissibility condition yields $f^{\prime}\left(u^{-}\right) \geq f^{\prime}\left(u^{+}\right)$and by the condition $f^{\prime \prime}<0$ this implies $u^{-} \leq u^{+}$.

By recalling the condition defining $\mathcal{U}$, we conclude that the limits $\lim _{t \rightarrow \tau^{+}}$ $w(t, \gamma(\tau))$ and $\lim _{t \rightarrow \tau^{-}} w(t, \gamma(\tau))$ both exist. If $\gamma^{\prime}(\tau)>0$, then

$$
\lim _{t \rightarrow \tau^{+}} w(t, \gamma(\tau))=f\left(u^{-}\right), \quad \lim _{t \rightarrow \tau^{-}} w(t, \gamma(\tau))=f\left(u^{+}\right)
$$

and by using the condition (3.2) we arrive at (3.1). If $\gamma^{\prime}(\tau)<0$ the analysis is similar. If $\gamma^{\prime}(\tau)=0$, then $w$ is continuous at $(\tau, \gamma(\tau))$.

Lemma 3.2. Assume $u_{0} \in C_{c}^{\infty}(\mathbb{R})$. Fix $x \in \mathbb{R}$ and a time interval $] 0, T[$ and assume that $u$ is of class $C^{1}$ in a neighborhood of every point $(t, x)$ except for a finite number of points $\left(\tau_{1}, x\right), \ldots,\left(\tau_{\ell}, x\right)$. We also assume that, for every $r=1, \ldots, \ell$, the entropy admissible solution $u$ satisfies the assumptions of Lemma 3.1 for a suitable $C^{1}$ curve $\left.\gamma_{r}:\right] t_{1 r}, t_{2 r}\left[\rightarrow \mathbb{R}\right.$ such that $\left.\tau_{r} \in\right] t_{1 r}, t_{2 r}\left[\right.$ and $\gamma_{r}\left(\tau_{r}\right)=x$. Then

$$
\begin{equation*}
\sup _{0 \leq t_{1}<t_{2}<\cdots<t_{p} \leq T} \sum_{\alpha=1}^{p-1}\left[w\left(t_{\alpha+1}, x\right)-w\left(t_{\alpha}, x\right)\right]^{+} \leq C\left(\operatorname{Tot} \operatorname{Var} w_{0}\right) \tag{3.3}
\end{equation*}
$$

In the previous expression, $[\cdot]^{+}$denotes the positive part and $w_{0}:=f \circ u_{0}$.

Note that, owing to the fact that $w(\cdot, x)$ is smooth outside $\tau_{1}, \ldots, \tau_{\ell}$, in computing the supremum in (3.3) we can assume without loss of generality that the sampling points do not coincide with any discontinuity point, that is, $t_{\alpha} \neq \tau_{r}$, for every $\alpha=$ $1, \ldots, p$ and every $r=1, \ldots, \ell$. This yields that the value $w\left(t_{\alpha}, x\right)$ is well defined.

Proof of Lemma 3.2. We fix a sampling $t_{1}, \ldots, t_{p}$ and by relying on the above observation we assume without loss of generality that $t_{\alpha} \neq \tau_{r}$ for every $\alpha=1, \ldots, p$ and every $r=1, \ldots, \ell$. To establish (3.3) we use the theory of so-called generalized characteristics and we refer to [23] for a comprehensive introduction. The rest of the proof is organized according to the following steps.

STEP 1: we establish some properties of generalized characteristics that we need in the following. We term $\xi_{t}^{-}$and $\xi_{t}^{+}$the minimal backward and the maximal backward characteristics emanating from the point $(t, x)$; see [23, Theorem 10.2.2]. We apply [23, Theorem 10.3.1] and we conclude that, for every $t \in \mathbb{R}_{+}, \xi_{t}^{-}$and $\xi_{t}^{+}$are a left and a right contact, respectively, in the sense of [23, Definition 10.2.5]. By applying [23, Formula (11.1.10)] in virtue of the fact that $f^{\prime \prime}<0$, we conclude that $\xi_{t}^{-}$and $\xi_{t}^{+}$are shock-free, in the sense of [23, Definition 10.2.4]. We apply [23, Theorem 11.1.1] and conclude that, for every $t \in \mathbb{R}_{+}, \xi_{t}^{-}$and $\xi_{t}^{+}$are segments with constant slope.

Next, we fix $\alpha=1, \ldots, p$, we recall that $t_{\alpha} \neq \tau_{r}$, for every $r=1, \ldots, \ell$, and by using [23, Theorem 11.1.3] we conclude that $\xi_{t_{\alpha}}^{-} \equiv \xi_{t_{\alpha}}^{+}$. Owing to [23, Theorem 10.2.2] we conclude that there is a unique backward characteristic emanating from the point $\left(t_{\alpha}, x\right)$ and we denote it by $\xi_{t_{\alpha}}: \mathbb{R}_{+} \rightarrow \mathbb{R}$. We recall that, by the previous analysis, $\xi_{t_{\alpha}}$ is shock-free, in the sense of [23, Definition 10.2.4]. Finally, we apply [23, Theorem 11.1.1] and we conclude that $u$ (and henceforth $w$ ) is constant along $\xi_{t_{\alpha}}$.

Step 2: we set

$$
\begin{equation*}
E^{-}:=\{t \in] 0, T\left[: \xi_{t}^{-}(0) \leq x\right\}, \quad E^{+}:=\{t \in] 0, T\left[: \xi_{t}^{+}(0) \geq x\right\}, \tag{3.4}
\end{equation*}
$$

we point out that $] 0, T\left[=E^{-} \cup E^{+}\right.$and we establish the following property: the maps $t \mapsto \xi_{t}^{-}(0)$ and $t \mapsto \xi_{t}^{+}(0)$ are monotone nonincreasing on $E^{-}$and monotone nondecreasing on $E^{+}$, respectively.

We show that $t \mapsto \xi_{t}^{+}(0)$ is monotone nondecreasing on $E^{+}$; the proof of the other claim is analogous. Assume by contradiction that there are $t_{1}, t_{2} \in E^{+}, t_{1}<t_{2}$, such that $\xi_{t_{1}}^{+}(0)>\xi_{t_{2}}^{+}(0)$. Owing to Step 1, $\xi_{t_{1}}^{+}$and $\xi_{t_{2}}^{+}$both have constant slope. Since $t_{1}<t_{2}$ and $\xi_{t_{1}}^{+}(0)>\xi_{t_{2}}^{+}(0)$, then $\xi_{t_{1}}$ and $\xi_{t_{2}}$ must cross at some $s<t_{1}$. Since, by Step $1, \xi_{t_{1}}^{+}$and $\xi_{t_{2}}^{+}$are both shock-free, this contradicts [23, Corollary 11.1.2] and hence concludes the proof of the claim.

Step 3. Since $] 0, T\left[=E^{-} \cup E^{+}\right.$, then

$$
\begin{equation*}
\sup _{0 \leq t_{1}<t_{2}<\cdots<t_{p} \leq T} \sum_{\alpha=1}^{p-1}\left[w\left(t_{\alpha+1}, x\right)-w\left(t_{\alpha}, x\right)\right]^{+} \leq S_{1}+S_{2}+S_{3}, \tag{3.5}
\end{equation*}
$$

where $S_{1}$ is the supremum of the sum over the $\alpha$ 's such that $t_{\alpha+1}$ and $t_{\alpha}$ both belong to $E^{-}, S_{2}$ is the supremum of the sum over the $\alpha$ 's such that $t_{\alpha+1}$ and $t_{\alpha}$ both belong to $E^{+}$, and $S_{3}$ is the supremum of the sum over the $\alpha$ 's such that $t_{\alpha+1} \in E^{-}$and $t_{\alpha} \in E^{+}$, or vice versa.

We first control the term $S_{1}$ in (3.5). We fix $\alpha$ such that $t_{\alpha+1}, t_{\alpha} \in E^{-}$. We recall that owing to Step 1 the backward characteristics emanating from $\left(t_{\alpha}, x\right)$ and $\left(t_{\alpha+1}, x\right)$ are both unique and that the function $w$ is constant along $\xi_{t_{\alpha+1}}$ and $\xi_{t_{\alpha}}$. This implies
$\left[w\left(t_{\alpha+1}, x\right)-w\left(t_{\alpha}, x\right)\right]^{+}=\left[w\left(\xi_{t_{\alpha+1}}(0)\right)-w\left(\xi_{t_{\alpha}}(0)\right)\right]^{+} \leq\left|w_{0}\left(\xi_{t_{\alpha+1}}(0)\right)-w_{0}\left(\xi_{t_{\alpha}}(0)\right)\right|$.

Next, we sum all the above contributions for $t_{\alpha}, t_{\alpha+1} \in E^{-}$and we recall that the $\operatorname{map} t \mapsto \xi_{t}^{-}(0)$ is monotone on $E^{-}$. This implies that when summing we are never computing twice the same interval and hence we eventually arrive at

$$
\begin{equation*}
S_{1} \leq \operatorname{Tot} \operatorname{Var} w_{0} \tag{3.6}
\end{equation*}
$$

By analogous considerations $S_{2} \leq \operatorname{Tot} \operatorname{Var} w_{0}$.
Step 4: we control the term $S_{3}$. We fix $\alpha$ and, just to fix the ideas, we assume that $t_{\alpha+1} \in E^{+}, t_{\alpha} \in E^{-}$. We set

$$
s_{\alpha}:=\sup \left\{s \leq t_{\alpha+1}: s \in E^{-}\right\}
$$

Next, we point out that

$$
\begin{aligned}
& {\left[w\left(t_{\alpha+1}, x\right)-w\left(t_{\alpha}, x\right)\right]^{+} \leq\left[w\left(t_{\alpha+1}, x\right)-\lim _{s \rightarrow s_{\alpha}^{+}} w(s, x)\right]^{+}} \\
& \quad+\left[\lim _{s \rightarrow s_{\alpha}^{+}} w(s, x)-\lim _{s \rightarrow s_{\alpha}^{-}} w(s, x)\right]^{+}+\left[\lim _{s \rightarrow s_{\alpha}^{-}} w(s, x)-w\left(t_{\alpha}, x\right)\right]^{+}
\end{aligned}
$$

We now separately consider two cases. If $w(\cdot, x)$ is continuous at $s_{\alpha}$, then the second term in the above sum vanishes. If $w(\cdot, x)$ is not continuous at $s_{\alpha}$, then $s_{\alpha}$ must coincide with one of the discontinuity points $\tau_{1}, \ldots, \tau_{\ell}$. We can then apply Lemma 3.1 and owing to (3.1) we conclude that also in this case the second term in the above sum vanishes. This yields

$$
\left[w\left(t_{\alpha+1}, x\right)-w\left(t_{\alpha}, x\right)\right]^{+} \leq\left[w\left(t_{\alpha+1}, x\right)-\lim _{s \rightarrow s_{\alpha}^{+}} w(s, x)\right]^{+}+\left[\lim _{s \rightarrow s_{\alpha}^{-}} w(s, x)-w\left(t_{\alpha}, x\right)\right]^{+}
$$

and we can control the above terms by arguing as in Step 3. This yields

$$
S_{1}+S_{2}+S_{3} \leq C\left(\operatorname{TotVar} w_{0}\right)
$$

and owing to (3.5) concludes the proof of (3.3).
3.2. Proof of Theorem 1.1. We proceed according to the following steps.

STEP 1: we show that (3.3) implies (1.3). This establishes (1.3) provided $u(\cdot, x)$ has the same regularity as in the statement of Lemma 3.2. To deduce (1.3) from (3.3) we recall that if $u(\cdot, x)$ has the same regularity as in the statement of Lemma 3.2, then

$$
\begin{equation*}
\operatorname{Tot} \operatorname{Var} w(\cdot, x)=\sup _{0 \leq t_{1}<t_{2}<\cdots<t_{p} \leq T} \sum_{\alpha=1}^{p-1}\left|w\left(t_{\alpha+1}, x\right)-w\left(t_{\alpha}, x\right)\right| . \tag{3.7}
\end{equation*}
$$

Next, we point out that

$$
\sum_{\alpha=1}^{p-1}\left[w\left(t_{\alpha+1}, x\right)-w\left(t_{\alpha}, x\right)\right]^{+}=\sum_{\alpha=1}^{p-1}\left[w\left(t_{\alpha+1}, x\right)-w\left(t_{\alpha}, x\right)\right]^{-}+w\left(t_{p}, x\right)-w\left(t_{1}, x\right)
$$

and by plugging the above expression into (3.7) and using (3.3) we arrive at

$$
\begin{equation*}
\operatorname{Tot} \operatorname{Var} w(\cdot, x) \leq C\left(\operatorname{Tot} \operatorname{Var} w_{0}\right) \tag{3.8}
\end{equation*}
$$

Step 2. We establish (1.3) under the further assumption that $u$ is smooth ouside (a) a finite number of $C^{1}$ curves, the so-called shocks, across which $u$ has a jump
discontinuity. At every point $(\tau, \gamma(\tau))$ belonging to the shock curve the assumptions of Lemma 3.1 are satisfied; (b) a finite number of points where two shocks interact (i.e., they intersect). We assume (a) and (b) and apply the coarea formula to each shock curve (or more precisely, to the $C^{1}$ function parameterizing each shock curve) and conclude that the hypotheses of Lemma 3.2 hold true for every $x \in \mathbb{R} \backslash N$, where $N$ is a negligible set. Owing to Step 1 , this implies that estimate (3.8) holds true for every $x \in \mathbb{R} \backslash N$. Next, we recall Lemma 2.1 and the fact that the total variation is lower semicontinuous with respect to weak* convergence: this implies that (3.8) holds true for every $x \in \mathbb{R}$.

Step 3: we conclude the proof of Theorem 1.1.
STEP 3A: we point out that, owing to the chain rule for $B V$ functions (see, for instance, [5, Theorem 3.96]), the fact that (3.8) holds for every $x \in \mathbb{R}$ yields (1.3).

STEP 3B: by relying on a standard truncation and mollification argument, we construct a sequence $\left\{u_{0 n}\right\}_{n \in \mathbb{N}} \subseteq C_{c}^{\infty}(\mathbb{R})$ such that

$$
\begin{equation*}
u_{0 n} \rightarrow u_{0}, \quad \operatorname{Tot} \operatorname{Var} u_{0 n} \rightarrow \operatorname{Tot} \operatorname{Var} u_{0} \quad \text { as } n \rightarrow+\infty \tag{3.9}
\end{equation*}
$$

STEP 3C: we apply the Schaeffer regularity theorem [42]. In particular, we apply the results by Dafermos [22] and we recall that since the flux function $f$ satisfies $f^{\prime \prime}<0$, then the entropy admissible solution $u$ of (1.1), (1.2) does not have contact discontinuities. By using [22, section 3] we conclude that from the sequence $\left\{u_{0 n}\right\}_{n \in \mathbb{N}}$ we can construct a second sequence $\left\{z_{0 n}\right\}_{n \in \mathbb{N}} \subseteq C_{c}^{\infty}(\mathbb{R})$ such that (3.9) holds true and furthermore the entropy admissible solution $u_{n}$ of the Cauchy problem obtained by coupling (3.9) with the condition $u(0, \cdot)=z_{0 n}$ satisfies conditions (a) and (b) in Step 2. Note that $u_{n}$ satisfies (1.3).

STEP 3D: we conclude the proof. We recall that the semigroup of entropy admissible solutions of $(1.1),(1.2)$ is $L^{1}$ stable with respect to the initial data; see [23, Formula (6.2.9)]. We conclude that the sequence $u_{n}$ constructed in Step 3C converges to the entropy admissible solution $u$ of the Cauchy problem (1.1), (1.2) in $L^{1}(] 0, T[\times \mathbb{R})$. This implies that, up to subsequences, for almost every $x \in \mathbb{R}, u_{n}(\cdot, x)$ converges to $u(\cdot, x)$ in $L^{1}(] 0, T[)$ and hence, by the lower semicontinuity of the total variation with respect to the $L^{1}$ strong convergence, $w(\cdot, x)$ satisfies (1.3). Finally, we recall Lemma 2.1 and the fact that the total variation is lower semicontinuous with respect to weak* convergence: this implies that (1.3) is satisfied for every $x \in \mathbb{R}$.

Remark 3.3. By relying on the proof of Theorem 1.1 one realizes that if the initial datum $u_{0}$ is continuous, then one can control the left-hand side of (1.3) with TotVar $w_{0}$. This is, however, not true in general: as a counterexample one can consider the Burgers' equation

$$
\begin{equation*}
\partial_{t} u+\partial_{x}\left(u^{2}\right)=0 \tag{3.10}
\end{equation*}
$$

and couple it with the Riemann-type initial datum

$$
u_{0}(x):= \begin{cases}-1, & x<0  \tag{3.11}\\ 1, & x>0\end{cases}
$$

Note that in this case $\operatorname{Tot} \operatorname{Var} w_{0}=0$; however, the solution of the Riemann problem (3.10), (3.11) is a rarefaction and (1.3) fails.
4. Further results on the time $B V$ regularity of entropy admissible solutions.
4.1. Proof of Proposition 1.2. In the following, just to fix the ideas, we assume $f^{\prime} \geq 0$ on [ess $\inf u_{0}$, ess sup $\left.u_{0}\right]$, the proof in the case $f^{\prime} \leq 0$ is analogous. We first establish (1.4) in the case of wave front-tracking approximate solutions and then we pass to the limit.
4.1.1. Wave front-tracking approximation. For the reader's convenience we briefly recall the construction of the wave front-tracking approximation. First, we fix $\nu \in \mathbb{N}$ and we consider the conservation law

$$
\begin{equation*}
\partial_{t} u^{\nu}+\partial_{x}\left[f^{\nu}\left(u^{\nu}\right)\right]=0, \tag{4.1}
\end{equation*}
$$

where $f^{\nu}$ is the piecewise affine approximation of $f$ defined by interpolating the values of $f$ and setting
$f^{\nu}(u):=\frac{u-2^{-\nu} j}{2^{-\nu}} f\left(2^{-\nu}(j+1)\right)+\frac{2^{-\nu}(j+1)-u}{2^{-\nu}} f\left(2^{-\nu} j\right) \quad$ if $u \in\left[2^{-\nu} j, 2^{-\nu}(j+1)\right], j \in \mathbb{Z}$.
Next, we fix $u_{0}^{\nu}: \mathbb{R} \rightarrow 2^{-\nu} \mathbb{Z}$ with bounded variation and compact support and we assign the initial datum

$$
\begin{equation*}
u^{\nu}(0, \cdot)=u_{0}^{\nu} . \tag{4.2}
\end{equation*}
$$

We then define the wave front-tracking approximate solution as the entropy admissible solution of the Cauchy problem (4.1), (4.2). Note that $u^{\nu}$ attains values in $2^{-\nu} \mathbb{Z}$ and that, for every $t>0$, the function $u^{\nu}(t, \cdot)$ is piecewise constant. Note furthermore that the discontinuity points of $u^{\nu}$ are contained in the graphs of finitely many Lipschitz continuous curves (the so-called fronts) $x_{j}, j=1, \ldots, N$, and that the assumption $f^{\prime} \geq 0$ yields $d x_{j} / d t \geq 0$ for every $j=1, \ldots, N$. We finally recall that there are only finitely many times at which a collision between two or more different fronts occurs. More precisely, we say that two fronts $x_{i}$ and $x_{j}$ collide at the time $\bar{t}$ if

$$
\begin{equation*}
\left.x_{i}(\bar{t})=x_{j}(\bar{t}) \quad \text { and } \quad \exists \varepsilon>0: x_{i}(t) \neq x_{j}(t) \quad \forall t \in\right] \bar{t}-\varepsilon, \bar{t}[. \tag{4.3}
\end{equation*}
$$

We now establish (1.4) in the case of wave front-tracking approximate solutions.
Lemma 4.1. Fix $f \in C^{2}(\mathbb{R}), \nu \in \mathbb{N}$, and term $u^{\nu}$ the wave front-tracking approximate solution with initial datum $u_{0}^{\nu}$. If $f^{\prime} \geq 0$ on the interval $\left[\operatorname{ess} \inf u_{0}\right.$, ess $\left.\sup u_{0}\right]$, then

$$
\begin{equation*}
\text { TotVar } u^{\nu}(\cdot, x) \leq \operatorname{TotVar} u_{0}^{\nu} \quad \text { for every } x \in \mathbb{R} \tag{4.4}
\end{equation*}
$$

Proof. We denote as before by $x_{j}, j=1, \ldots, n$, the wave fronts and we point out that
(i) since $d x_{j} / d t \geq 0$ for every $j=1, \ldots, N$, then for every but countably many $x \in \mathbb{R}$ there is a unique time $t_{j}$ such that $x_{j}\left(t_{j}\right)=x$;
(ii) by removing (if needed) a further finite set of $x$ 's we can assume that no collision between different fronts occurs at time $t_{j}$;
(iii) for the same $x$ as in point (i) we have $u^{\nu}\left(t, x^{+}\right)=u^{\nu}\left(t, x^{-}\right)$for every but finitely many $t \in] 0,+\infty[$.
Fix $\bar{x}$ satisfying properties (i), (ii), and (iii) above and consider the function $G_{\bar{x}}^{\nu}$ : $] 0,+\infty\left[\rightarrow \mathbb{R}\right.$ defined by setting $G_{\bar{x}}^{\nu}(t):=G_{\bar{x}, 1}^{\nu}(t)+G_{\bar{x}, 2}^{\nu}(t)$, where (4.5)


Assume for a moment that we have shown that $G_{\bar{x}}^{\nu}$ is a monotone nonincreasing function; then this yields (4.4) since

$$
\operatorname{Tot} \operatorname{Var} u^{\nu}(\cdot, \bar{x}) \leq \lim _{t \rightarrow \infty} G_{\overline{\bar{x}}}^{\nu}(t) \leq \lim _{t \rightarrow 0^{+}} G_{\overline{\bar{x}}}^{\nu}(t)=\operatorname{Tot} \operatorname{Var}_{]-\infty, \bar{x}[ } u_{0}^{\nu} \leq \operatorname{Tot} \operatorname{Var} u_{0}^{\nu} .
$$

We are thus left to show that $G_{\bar{x}}^{\nu}$ is a monotone nonincreasing function. To this end, we point out that, by construction, the functions $G_{\bar{x}, 1}^{\nu}, G_{\bar{x}, 2}^{\nu}$ and therefore $G_{\bar{x}}^{\nu}$ are piecewise constant. Also, $G_{\bar{x}, 1}^{\nu}$ is a monotone nonincreasing function: more precisely, it can only diminish at times when an interaction between wave fronts occurs on the interval $]-\infty, \bar{x}\left[\right.$. Since discontinuities of $G_{\bar{x}, 2}^{\nu}$ can only occur at a point $t_{j}$ as in item (i) above, to conclude it suffices to show that for every $j=1, \ldots, N$ we have $G_{\bar{x}}^{\nu}\left(t_{j}^{-}\right)=G_{\bar{x}}^{\nu}\left(t_{j}^{+}\right)$. To this end, we point out that

$$
\begin{align*}
& G_{\bar{x}, 1}^{\nu}\left(t_{j}^{+}\right)-G_{\bar{x}, 1}^{\nu}\left(t_{j}^{-}\right)=-\left|u^{\nu}\left(t_{j}, \bar{x}^{+}\right)-u^{\nu}\left(t_{j}, \bar{x}^{-}\right)\right|, \\
& G_{\bar{x}, 2}^{\nu}\left(t_{j}^{+}\right)-G_{\bar{x}, 2}^{\nu}\left(t_{j}^{-}\right)=\left|u^{\nu}\left(t_{j}, \bar{x}^{+}\right)-u^{\nu}\left(t_{j}, \bar{x}^{-}\right)\right| . \tag{4.6}
\end{align*}
$$

In particular $G_{\bar{x}}^{\nu}\left(t_{j}^{-}\right)=G_{\bar{x}, 1}^{\nu}\left(t_{j}^{-}\right)+G_{\bar{x}, 2}^{\nu}\left(t_{j}^{-}\right)=G_{\bar{x}, 1}^{\nu}\left(t_{j}^{+}\right)+G_{\bar{x}, 2}^{\nu}\left(t_{j}^{+}\right)=G_{\bar{x}}^{\nu}\left(t_{j}^{+}\right)$. This establishes (4.4) for every $\bar{x} \in E$ for some suitable set $E$ such that $\mathcal{L}^{1}(\mathbb{R} \backslash E)=0$. We are left to show that actually (4.4) holds for every $x \in \mathbb{R}$ : to this end, we recall Lemma 2.3 and the lower semicontinuity of the total variation with respect to the $L^{1}$-convergence and we conclude that

$$
\begin{align*}
& \text { TotVar } u^{\nu}\left(\cdot, x^{+}\right) \leq \liminf _{x_{n} \uparrow x} \operatorname{TotVar} u^{\nu}\left(\cdot, x_{n}\right) \leq \operatorname{TotVar} u_{0}, \\
& \text { TotVar } u^{\nu}\left(\cdot, x^{-}\right) \leq \liminf _{y_{n} \downarrow x} \operatorname{TotVar} u^{\nu}\left(\cdot, y_{n}\right) \leq \operatorname{TotVar} u_{0} \tag{4.7}
\end{align*}
$$

for suitable sequences $\left\{x_{n}\right\}_{n \in \mathbb{N}},\left\{y_{n}\right\}_{n \in \mathbb{N}} \subseteq E$.
Proof of Proposition 1.2. Given $u_{0} \in B V(\mathbb{R})$ we fix a family $\left\{u_{0}^{\nu}\right\} \subseteq B V(\mathbb{R})$ with compact support attaining values in $2^{-\nu} \mathbb{Z}$ such that $u_{0}^{\nu} \rightarrow u_{0}$ in $L^{1}(\mathbb{R})$ and $\operatorname{Tot} \operatorname{Var} u_{0}^{\nu} \rightarrow \operatorname{TotVar} u_{0}$ as $\nu \rightarrow 0^{+}$(see [12, Lemma 2.2]). Let $u^{\nu}$ be the corresponding family of wave front-tracking approximate solutions with initial datum $u_{0}^{\nu}$. By the analysis in [12, Chapter 6] we infer that $u^{\nu} \rightarrow u$ in $L_{\text {loc }}^{1}$ ( $] 0,+\infty[\times \mathbb{R}$ ). This implies that $u^{\nu}(\cdot, x) \rightarrow u(\cdot, x)$ in $L_{\text {loc }}^{1}(] 0,+\infty[)$ for a.e. $x \in \mathbb{R}$. Since for a.e. $x \in \mathbb{R}$ we have $u\left(\cdot, x^{+}\right)=u\left(\cdot, x^{-}\right)$, then by combining Lemma 4.1 with the lower semicontinuity of the total variation we get
$\operatorname{TotVar} u(\cdot, x) \leq \liminf _{\nu \rightarrow \infty} \operatorname{TotVar} u^{\nu}(\cdot, x) \stackrel{(4.4)}{\leq} \liminf _{\nu \rightarrow \infty} \operatorname{TotVar} u_{0}^{\nu}=\operatorname{TotVar} u_{0} \quad$ for a.e. $x \in \mathbb{R}$
By using the same approximation argument as in the proof of Lemma 4.1 we conclude that the above estimate holds for every $x \in \mathbb{R}$.
4.2. Initial-boundary value problems. Theorem 1.1 and Proposition 1.2 have several extensions to initial-boundary value problems. Here we only explicitly discuss the extension we need in the proof of Theorem 1.5 and of Corollary 1.6.

Corollary 4.2. Fix $f \in C^{2}(\mathbb{R}), \bar{u} \in B V(] 0, T[), u_{0} \in B V(] \alpha, \beta[)$. Assume furthermore that $f^{\prime} \geq 0$ on the interval $\left[\min \left\{\inf \bar{u}, \inf u_{0}\right\}, \max \left\{\sup \bar{u}, \sup u_{0}\right\}\right]$. Let $u$ be the unique entropy admissible solution of the initial-boundary value problem (1.1), (2.6). Then
$\operatorname{TotVar} u\left(\cdot, x^{ \pm}\right) \leq \operatorname{Tot} \operatorname{Var} u_{0}+\operatorname{Tot} \operatorname{Var} \bar{u}+\left|u_{0}\left(\alpha^{+}\right)-\bar{u}\left(0^{+}\right)\right| \quad$ for every $\left.x \in\right] \alpha, \beta[$.

In the above expression, we denote by $u_{0}\left(\alpha^{+}\right)$and $\bar{u}\left(0^{+}\right)$the right limit of $u_{0}$ and $\bar{u}$ at $x=\alpha$ and $t=0$, respectively. ${ }^{2}$

Under the same assumptions as in Corollary 4.2, the trace at $x=\beta$ of the entropy admissible solution of the initial-boundary value problem (1.1), (2.6) is well defined and we denote it by $u_{\beta}$. By using the lower semicontinuity of the total variation with respect to the strong convergence we conclude that

$$
\begin{equation*}
\operatorname{Tot} \operatorname{Var} u_{\beta} \leq \operatorname{Tot} \operatorname{Var} u_{0}+\operatorname{Tot} \operatorname{Var} \bar{u}+\left|u_{0}\left(\alpha^{+}\right)-\bar{u}\left(0^{+}\right)\right| \tag{4.10}
\end{equation*}
$$

Remark 4.3. Even if we do not explicitly discuss it, Theorem 1.1 extends to initialboundary value problems and provides a control of $\operatorname{Tot} \operatorname{Var} w(\cdot, x)$ for every $x \in] \alpha, \beta[$. As in the case of the Cauchy problem, if $f^{\prime}$ changes sign we cannot hope for a control on the total variation of $u$ : for a counterexample, we refer to the construction detailed in section 4.3, which also applies to initial-boundary value problems.

Proof of Corollary 4.2. We only provide a sketch of the proof, which is based on the same argument as the proof of Proposition 1.2. The key point is the construction of the wave front-tracking approximation of the initial-boundary value problem (1.1), (2.6). We fix $\nu \in \mathbb{N}$ and $\left.\bar{u}^{\nu}:\right] 0, T\left[\rightarrow 2^{-\nu} \mathbb{Z}\right.$, we assign the boundary datum

$$
\begin{equation*}
u^{\nu}(\cdot, \alpha)=\bar{u}^{\nu} \tag{4.11}
\end{equation*}
$$

and we construct the entropy admissible solution of the initial-boundary value problem (4.1), (4.2), (4.11). To construct the wave front-tracking approximation, the main difference with respect to the Cauchy problem is that we have to define the solution of the initial-boundary value problem obtained by coupling (4.1) with the data

$$
\begin{equation*}
u^{\nu}(\cdot, \alpha)=u_{b}, \quad u^{\nu}(0, \cdot)=u_{i} \tag{4.12}
\end{equation*}
$$

where $u_{b}, u_{i} \in 2^{-\nu} \mathbb{Z}$ satisfy $\left(f^{\nu}\right)^{\prime}\left(u_{b}^{ \pm}\right) \geq 0,\left(f^{\nu}\right)^{\prime}\left(u_{i}^{ \pm}\right) \geq 0$. We term $z$ the entropy admissible solution of the Cauchy problem obtained by coupling (4.1) with the initial datum

$$
u^{\nu}(0, x):= \begin{cases}u_{b}, & x<\alpha \\ u_{i}, & x>\alpha\end{cases}
$$

We claim that the restriction of $z$ to $] \alpha, \beta[$ is the entropy admissible solution of the initial-boundary problem (4.1), (4.12). To see this we have to verify (2.7). First, we point out that $z$ satisfies the entropy inequality inside the domain $[0, T[\times] \alpha, \beta[$, namely

\begin{equation*}
\int_{0}^{T} \int_{\alpha}^{\beta}|z-c| \partial_{t} \phi+\operatorname{sign}(z-c)\left[f^{\nu}(z)-f^{\nu}(c)\right] \partial_{x} \phi d x d t+\int_{\alpha}^{\beta} \phi(0, \cdot)\left|u_{i}-c\right| d x \geq 0 \tag{4.13}
\end{equation*}
$$

for every $c \in \mathbb{R}$ and every $\phi \in C_{c}^{\infty}(]-\infty, T[\times] \alpha, \beta[)$ such that $\phi \geq 0$. Next, we claim that

$$
\begin{equation*}
\left.\left[\operatorname{sign}\left(u_{b}-c\right)-\operatorname{sign}\left(z_{\alpha}-c\right)\right]\left[f^{\nu}\left(z_{\alpha}\right)-f^{\nu}(c)\right]=0, \quad \text { a.e. on }\right] 0, T[. \tag{4.14}
\end{equation*}
$$

To see this, we recall that, since $\left(f^{\nu}\right)^{\prime} \geq 0$, then $f^{\nu}\left(z_{\alpha}\right)=f^{\nu}\left(u_{b}\right)$ and by a case-bycase analysis we arrive at (4.14). Next, we fix a parameter $\varepsilon>0$ and set $\eta_{\varepsilon}:=1-\omega_{\varepsilon}$, where $\omega_{\varepsilon} \in C^{\infty}(\mathbb{R})$ is the same family as in (2.9). We then fix a test function

[^2]$\varphi \in C_{c}^{\infty}(]-\infty, T[\times]-\infty, \beta[)$, plug the test function $\phi_{\varepsilon}(t, x):=\varphi(t, x) \eta_{\varepsilon}(x)$ into (4.13), and let $\varepsilon \rightarrow 0^{+}$. By using the fact that
\[

& \int_{0}^{T} \int_{\alpha}^{\beta} \operatorname{sign}(z-c)\left[f^{\nu}(z)-f^{\nu}(c)\right] \eta_{\varepsilon}^{\prime} \varphi d x d t \\
& \quad \rightarrow \int_{0}^{T} \operatorname{sign}\left(z_{\alpha}-c\right)\left[f^{\nu}\left(z_{\alpha}\right)-f^{\nu}(c)\right] \varphi(\cdot, \alpha) d t \quad \text { as } \varepsilon \rightarrow 0^{+}
\end{aligned}
$$
\]

and recalling (4.14) we arrive at (2.7).
Once we have constructed the wave front-tracking approximation, the proof follows the same argument as the proof of Proposition 1.2, with the only difference that the term $G_{\bar{x}, 1}^{\nu}$ in (4.5) should be replaced by

G_{\bar{x}, 3}^{\nu}(t):=\operatorname{Tot}_{\operatorname{Var}}^{] \alpha, \bar{x}[ } u^{\nu}(t, \cdot)+\left|\bar{u}^{\nu}\left(t^{+}\right)-u^{\nu}\left(t, \alpha^{+}\right)\right|+\operatorname{Tot}_{\operatorname{Var}}^{] t,+\infty[ } \bar{u}^{\nu}

4.3. An example of total variation blow-up for $\boldsymbol{u}(\cdot, \mathbf{0})$. In this section we exhibit an explicit counterexample showing that if $f^{\prime}(u)$ can change sign, then the total variation of the entropy admissible solution $u(\cdot, 0)$ can blow up in finite time, even if the initial data (in the case of the Cauchy problem) or the initial and boundary data (in the case of the initial-boundary value problem) have bounded total variation. More precisely, we have the following result.

Proposition 4.4. There are $r>0$ and $u_{0} \in B V(\mathbb{R})$ such that the entropy admissible solution of the Cauchy problem obtained by coupling the Burgers' equation (3.10) with the initial datum $u(0, \cdot)=u_{0}$ and the entropy admissible solution of the initialboundary problem obtained by coupling (3.10) with the conditions

$$
u(0, \cdot)=u_{0}, \quad u(\cdot,-r-1)=0, \quad u(\cdot, 1)=-1
$$

satisfy TotVar $\left.u(\cdot, 0)\right|_{] 0,2^{-3}[ }=+\infty$.
4.3.1. Construction roadmap. We consider the Burgers' equation (3.10) and we first provide a heuristic discussion of the basic ideas underpinning the contruction of the counterexample. The key point in the analysis is the construction of a map $\gamma:] 0, T[\rightarrow \mathbb{R}, T>0$ to be determined in the following, which exhibits the following features (see Figure 2 for a representation):

- the curve $\gamma$ crosses the vertical axis $x=0$ infinitely many times;
- there is a function $\left.u_{-}:\right] 0, T\left[\rightarrow \mathbb{R}\right.$ such that (i) $u_{-}(t) \sim 1$; (ii) $u_{-}(t)$ and $u_{+}(t)=-1$ satisfy the Rankine-Hugoniot conditions

$$
\begin{equation*}
u_{-}(t)^{2}-u_{+}(t)^{2}=\gamma^{\prime}(t)\left[u_{-}(t)-u_{+}(t)\right] \Longleftrightarrow \gamma^{\prime}(t)=u_{-}(t)-1 \tag{4.15}
\end{equation*}
$$

Since in the case of convex fluxes the Lax entropy admissible conditions boil down to the inequality $u_{-}(t) \geq u_{+}(t)$, the equality (4.15) dictates that $\gamma$ is an (entropy admissible) shock curve between $u_{-}(t)$ (on the left) and -1 (on the right).
Assume for a moment that $\gamma$ is indeed the shock curve of the solution $u$ of a Cauchy problem; then the total variation of $u(\cdot, 0)$ must blow up: indeed, $u$ is close to 1 on the left of $\gamma$ and equal to -1 on the right. Since $\gamma$ crosses the vertical axis $x=0$ infinitely many times, then $u(\cdot, 0)$ oscillates infinitely many times between a value close to 1 and the value -1 , and hence its total variation must blow up.


Fig. 2. A solution $u$ of the Burgers equation with $\operatorname{Tot} \operatorname{Var} u(\cdot, 0)=+\infty$.

To construct the initial datum $u_{0}$ of this Cauchy problem, we proceed as follows. First, we recall that, in the subsets of the $(t, x)$ plane where $u$ is regular, $u$ is constant along the characteristic lines, which have speed $2 u$. Next, we consider the line $\xi_{t}$ with slope $2 u_{-}(t)$ and passing through the point $(t, \gamma(t))$ and we define it on the interval $[0, t]$ since we want to focus on backward characteristics. Since $u_{-}(t)=1+\gamma^{\prime}(t)$ owing to (4.15), then the backward characteristic passing through $\left(t, \gamma(t)^{-}\right)$is

$$
\begin{equation*}
\xi_{t}(s)=2\left[1+\gamma^{\prime}(t)\right] s+\gamma(t)-2\left[1+\gamma^{\prime}(t)\right] t, \quad s \in[0, t] \tag{4.16}
\end{equation*}
$$

By enforcing suitable conditions on $\gamma$, we get that if $t_{1} \neq t_{2}$, then $\xi_{t_{1}}$ and $\xi_{t_{2}}$ do not cross. In this way we can "pull back" the values of $u_{-}(t)$ to the initial time and define the initial datum $u_{0}$ in such a way that $u_{0}\left(\xi_{t}(0)\right)=u_{-}(t)$. We can then easily enforce the condition $\operatorname{Tot} \operatorname{Var} u_{0}<+\infty$ and extend the construction to define an initial-boundary value problem. This "backward construction" is somewhat reminiscent of the analysis in [1, 2]; see also [23] for a general discussion about characteristics for conservation laws.
4.3.2. Technical details. We now provide the detailed construction of the counterexample, which is achieved in several steps.

STEP 1: construction of the "building blocks" of the curve $\gamma$. The curve $\gamma$ is constructed by alternatively patching together suitably rescaled "right curved" and "left curved" blocks. We first construct the right curved building block. We fix a parameter $\varepsilon<1$ and we set

\begin{equation*}
\hat{\gamma}_{\varepsilon}:[0, \varepsilon] \rightarrow \mathbb{R}, \quad \hat{\gamma}_{\varepsilon}(t)=\frac{1}{2 \varepsilon} t^{3}-\frac{3}{2} t^{2}+\varepsilon t \tag{4.17}
\end{equation*}
$$

Note that
(4.18)

$$
\hat{\gamma}_{\varepsilon}(0)=0, \quad \hat{\gamma}_{\varepsilon}(\varepsilon)=0, \quad \hat{\gamma}_{\varepsilon}^{\prime}(0)=\varepsilon, \quad \hat{\gamma}_{\varepsilon}^{\prime}(\varepsilon)=-\frac{\varepsilon}{2}, \quad \hat{\gamma}_{\varepsilon} \geq 0, \quad \hat{\gamma}_{\varepsilon}^{\prime \prime} \leq 0 \text { on }[0, \varepsilon] .
$$

STEP 2: analysis of backward characteristics. We recall (4.16) and we point out that

$$
\begin{equation*}
\frac{\partial \xi_{t}}{\partial t}(s)=2 \gamma^{\prime \prime}(t)[s-t]-\gamma^{\prime}(t)-2 \tag{4.19}
\end{equation*}
$$

which yields

$$
\begin{equation*}
\left.\left.\gamma^{\prime \prime}(t)<0 \Longrightarrow \frac{\partial \xi_{t}}{\partial t}(s)<0 \text { for } s \in\right] s_{0}(t), t\right], \text { where } s_{0}(t)=t+\frac{\gamma^{\prime}(t)+2}{2 \gamma^{\prime \prime}(t)} \tag{4.20}
\end{equation*}
$$

Let us focus on the case $\gamma=\hat{\gamma}_{\varepsilon}$ : we have $\gamma^{\prime \prime}(t)=0$ if and only if $t=\varepsilon$ and $\gamma^{\prime \prime}(t)<0$ if $t \in\left[0, \varepsilon\left[\right.\right.$. If $t=\varepsilon$, then $\partial \xi_{t} / \partial t=-\hat{\gamma}_{\varepsilon}^{\prime}(\varepsilon)-2<0$ for every $s \in \mathbb{R}$. If $t \in[0, \varepsilon[$, then
$s_{0}(t)=t+\frac{\hat{\gamma}_{\varepsilon}^{\prime}(t)+2}{2 \hat{\gamma}_{\varepsilon}^{\prime \prime \prime}(t)} \leq t+\sup _{t \in[0, \varepsilon[ } \frac{\hat{\gamma}_{\varepsilon}^{\prime}(t)+2}{2 \hat{\gamma}_{\varepsilon}^{\prime \prime}(t)} \stackrel{\hat{\gamma}_{\varepsilon}^{\prime \prime} \leq 0, \hat{\gamma}_{\varepsilon}^{\prime}>-2}{\leq} t+\frac{\inf _{t \in[0, \varepsilon[ } \hat{\gamma}_{\varepsilon}^{\prime}(t)+2}{\inf _{t \in[0, \varepsilon[ } 2 \hat{\gamma}_{\varepsilon}^{\prime \prime}(t)} \stackrel{(4.17)}{\leq} t+\frac{1}{-6}=t-\frac{1}{6}$.
Summing up, we conclude that

$$
\begin{equation*}
\frac{\partial \xi_{t}}{\partial t}<0 \quad \text { for every } t \in[0, \varepsilon] \text { and } s>t-\frac{1}{6} \tag{4.21}
\end{equation*}
$$

Finally, we define the left curved building block as $-\hat{\gamma}_{\varepsilon}(t)$. Note that the speed of the minimal backward characteristic through $\left(t,-\hat{\gamma}_{\varepsilon}(t)^{-}\right)$is $2\left[1-\hat{\gamma}_{\varepsilon}^{\prime}\right]$ and, since $\hat{\gamma}_{\varepsilon}^{\prime \prime} \leq 0$, then the backward characteristics do not intersect, namely

$$
\begin{equation*}
\frac{\partial \xi_{t}}{\partial t}<0 \quad \text { for every } t \in[0, \varepsilon] \text { and } s \leq t \tag{4.22}
\end{equation*}
$$

Step 3: we define the shock curve $\gamma$. We set

$$
\begin{gather*}
\gamma(t):=\sum_{n=3}^{\infty}(-1)^{n} \hat{\gamma}_{\varepsilon_{n}}\left(t-\tau_{n}\right) \mathbb{1}_{I_{n}}(t),  \tag{4.23}\\
\varepsilon_{n}:=2^{-(n+1)}, I_{n}:=\left[2^{-3}-2^{-n}, 2^{-3}-2^{-(n+1)}\left[, \tau_{n}:=2^{-3}-2^{-n} .\right.\right.
\end{gather*}
$$

In the above expression, $\mathbb{1}_{I_{n}}$ denotes the characteristic function of the interval $I_{n}$. Note that the intervals $I_{n}$ are disjoints and hence the above series converges since it is locally finite. Note furthermore that $\gamma$ is obtained by patching together infinitely many $C^{\infty}$ arcs and that at the junction points both the functions and its first derivatives match, hence $\gamma \in C^{1}(] 0,2^{-3}[)$. We now consider the backward characteristics with final point $\left(t, \gamma(t)^{-}\right)$, and we recall (4.16), (4.21), and (4.22). Since $2^{-3}<1 / 6$, we conclude that the map $t \mapsto \xi_{t}(0)$ is strictly decreasing (and henceforth injective) on $\left[0,2^{-3}\left[\right.\right.$. Owing to (4.16) and to the fact that $\gamma \in C^{1}$, it is also continuous, and hence the image of the interval $\left[0,2^{-3}\right.$ [ is an interval, which we term ] $\left.r, 0\right]$. The exact expression of the number $r>0$ could be explicitly computed but is not relevant here. We term $\varphi:]-r, 0] \rightarrow\left[0,2^{-3}\left[\right.\right.$ the inverse of the map $t \mapsto \xi_{t}(0)$. We can now define the initial datum $u_{0}: \mathbb{R} \rightarrow \mathbb{R}$ by setting

$$
u_{0}(x):= \begin{cases}0, & x<-r  \tag{4.24}\\ 1+\gamma^{\prime}(\varphi(x)), & -r<x<0 \\ -1, & x>0\end{cases}
$$

Note that

$$
\begin{equation*}
\operatorname{Tot} \operatorname{Var} u_{0} \leq 5+\sum_{n=3}^{\infty} \int_{I_{n}}\left|\gamma^{\prime \prime}(t)\right| d t=5+\sum_{n=3}^{\infty} 2^{-(n+2)}<+\infty \tag{4.25}
\end{equation*}
$$

STEP 4: we show that the entropy admissible solution of the Cauchy problem obtained by coupling (3.10) with (4.24) satisfies TotVar $u(\cdot, 0)=+\infty$. The entropy admissible solution $u$ is given by

$$
u(t, x)= \begin{cases}0, & x<\lim _{y \rightarrow-r^{+}} \xi_{\varphi(y)}(t)  \tag{4.26}\\ 1+\gamma^{\prime}(\varphi(y)), & x=\xi_{\varphi(y)}(t), x<\gamma(t) \\ -1, & x>\gamma(t)\end{cases}
$$

In other words, $u$ is identically equal to -1 for $x>\gamma(t)$, and it is transported along the characteristic lines (4.16) for $x<\gamma(t)$. Note that by construction the characteristics do not intersect on the set $x<\gamma(t)$. We then get

$$
\begin{equation*}
\operatorname{Tot} \operatorname{Var} u(\cdot, 0) \geq \sum_{n=3}^{\infty}\left|u\left(\sigma_{n+1}, 0\right)-u\left(\sigma_{n}, 0\right)\right|, \quad \sigma_{n}=2^{-3}-\frac{3}{2} 2^{-(n+1)} \tag{4.27}
\end{equation*}
$$

Note that $\sigma_{n}$ is the middle point of the interval $I_{n}$ and that $\left(\sigma_{n}, 0\right)$ is a continuity point for $u$. Note furthermore that if $n$ is odd, then $u\left(\sigma_{n}, 0\right)=-1$. If $n$ is even, $u\left(\sigma_{n}, 0\right)=1+\gamma^{\prime}(\varphi(x))$, for some $\left.\left.x \in\right]-r, 0\right]$. Since $1+\gamma^{\prime}(\varphi(x))>0$, then by using (4.27) we conclude that

$$
\operatorname{Tot} \operatorname{Var} u(\cdot, 0) \geq \sum_{n=3, n \text { odd }}^{\infty} 1=+\infty
$$

and this concludes the analysis of the Cauchy problem.
STEP 5: extension to the initial-boundary value problem. By restricting the function $u$ in (4.26) to the strip ] $-r-1,1$ [ we get a solution of the initial boundary value problem obtained by coupling (3.10) with the initial datum (4.24) and the boundary data $u(t,-r-1) \equiv 0, u(t, 1) \equiv-1$.
5. The multipath model: Distributional formulation, existence, and uniqueness results.
5.1. Distributional formulation of the initial-boundary value problem (1.8), (1.12), and (1.14). We now complete the definition of distributional solution of the multipath model. We first need some preliminary remarks: fix $r_{k} \in$ $L^{\infty}(] 0, T\left[\times P_{k}\right)$ and assume that $\theta_{k} \in L^{\infty}(] 0, T\left[\times P_{k}\right)$ satisfies

$$
\begin{equation*}
\int_{0}^{T} \int_{\alpha}^{\beta} r_{k} \theta_{k}\left(\partial_{t} \phi+v\left(r_{k}\right) \partial_{x} \phi\right) d x d t=0 \quad \text { for every } \phi \in C_{c}^{\infty}(] 0, T\left[\times P_{k}\right) \tag{5.1}
\end{equation*}
$$

By applying Lemma 2.11 with $b=v\left(r_{k}\right)$ and $] \alpha, \beta\left[=P_{k}\right.$ we define the initial value $\left[r_{k} \theta_{k}\right]_{0}$ and the distributional trace $\operatorname{Tr}\left[v\left(r_{k}\right) r_{k} \theta_{k}\right]\left(\cdot, a^{+}\right)$, where we recall that $a$ is the starting point of the path $P_{k}$. Also, assume that $r_{k}$ is obtained by patching together the $\rho_{i}^{\prime}$ s as in (1.9) and that each $\rho_{i}$ is an entropy admissible solution of (1.5), that is, it satisfies $(2.2)$ with $f\left(\rho_{i}\right)=v\left(\rho_{i}\right) \rho_{i}$. Then owing to Theorem 2.4 the trace $v\left(r_{k}\right) r_{k}\left(\cdot, a^{+}\right)$is attained as a strong limit in the $L^{1}$ topology.

Definition 5.1. Assume that $r_{k}$ satisfies (1.9), where each $\rho_{i}$ is an entropy admissible solution of (1.5), (1.11). We term $\theta_{k} \in L^{\infty}\left(\mathbb{R}_{+} \times P_{k}\right)$ a distributional solution of the initial-boundary value problem (1.8), (1.12), and (1.14) if $\theta_{k}$ satisfies (2.13) with $b=v\left(r_{k}\right)$ and furthermore

$$
\begin{align*}
& \operatorname{Tr}\left[v\left(r_{k}\right) r_{k} \theta_{k}\right]\left(\cdot, a^{+}\right)=\bar{\theta}_{k} v\left(r_{k}\right) r_{k}\left(\cdot, a^{+}\right),  \tag{5.2}\\
& {\left[r_{k} \theta_{k}\right]_{0}=\theta_{k 0} \rho_{i 0} \text { on } I_{i}, \text { for every } i \text { such that } I_{i} \subseteq P_{k} .}
\end{align*}
$$

We have the next lemma.
Lemma 5.2. Assume that $r_{k}$ satisfies (1.9), where each $\rho_{i}$ is an entropy admissible solution of (1.5), (1.11). Assume furthermore that $\theta_{k} \in L^{\infty}(] 0, T\left[\times P_{k}\right)$ is a distributional solution of (1.8), (1.12), (1.14). Under (1.15), (1.16), the following conditions are equivalent:
(i) (1.18) is satisfied a.e. on $] 0, T\left[\times I_{i}\right.$, for every $i$;
(ii) we have the equality

$$
\begin{equation*}
g\left(\rho_{j+1}\right)\left(\cdot, d^{+}\right) \stackrel{(1.7)}{=} v\left(\rho_{j+1}\right) \rho_{j+1}\left(\cdot, d^{+}\right)=\sum_{k: I_{j+1} \subseteq P_{k}} \operatorname{Tr}\left[v\left(\rho_{j}\right) \rho_{j} \theta_{k}\right]\left(\cdot, d^{-}\right) \tag{5.3}
\end{equation*}
$$

at every junction point $d$. In the above expression $d$ is the final point of the road $I_{j}$ entering the junction and the starting point of the road $I_{j+1}$ exiting the junction.
Proof of Lemma 5.2. Step 1: we establish the implication (i) $\Longrightarrow$ (ii). We apply (1.18) on the road $I_{j+1}$ and obtain the second of the equalities

$$
\begin{aligned}
& v\left(\rho_{j+1}\right) \rho_{j+1}\left(\cdot, d^{+}\right) \stackrel{(2.15)}{=}-\operatorname{Tr}\left[v\left(\rho_{j+1}\right) \rho_{j+1}\right]\left(\cdot, d^{+}\right) \stackrel{(1.18)}{=}-\sum_{k: I_{j+1} \subseteq P_{k}} \operatorname{Tr}\left[v\left(r_{k}\right) r_{k} \theta_{k}\right]\left(\cdot, d^{+}\right) \\
& \stackrel{(2.16)}{=} \sum_{k: I_{j+1} \subseteq P_{k}} \operatorname{Tr}\left[v\left(r_{k}\right) r_{k} \theta_{k}\right]\left(\cdot, d^{-}\right),
\end{aligned}
$$

and owing to (1.9) this yields (5.3).
STEP 2: we establish the implication (ii) $\Longrightarrow$ (i). We argue by induction. First, we show that (1.18) holds on $] 0, T\left[\times I_{1}\right.$. To this end, we set $z:=\sum_{k=1}^{m} \theta_{k}$ and we point out that, owing to (1.15) and (1.16) and to the linearity of the equation for $\theta_{k}$, $z$ is a solution of the initial-boundary value problem

$$
\left\{\begin{array}{l}
\partial_{t}\left[\rho_{1} z\right]+\partial_{x}\left[v\left(\rho_{1}\right) \rho_{1} z\right]=0,  \tag{5.4}\\
z(0, \cdot)=1, \quad z(\cdot, a)=1,
\end{array}\right.
$$

where we recall that $a$ is the initial point of the interval $I_{1}$. Owing to (1.5), $z \equiv$ 1 is a solution of the above initial-boundary value problem. We can then apply Theorem 2.15 with $] \alpha, \beta\left[=I_{1}, b=v\left(\rho_{1}\right)\right.$ and by the uniqueness part we conclude that (1.18) holds true on $] 0, T\left[\times I_{1}\right.$.

Next, we fix $i=2, \ldots, n_{k}$, assume that (1.18) holds true on $] 0, T\left[\times I_{j}\right.$ for $j=$ $1, \ldots, i-1$, and, under (5.3), show that it holds true on $] 0, T\left[\times I_{i}\right.$. To this end, we term $d$ the junction point between the road $I_{i-1}$ and the road $I_{i}$, that is, $d$ is the final
point of the road $I_{i-1}$ and the initial point of the road $I_{i}$. We recall (1.9) and point out that

$$
\begin{aligned}
\operatorname{Tr}\left[\sum_{k: I_{i} \subseteq P_{k}} v\left(\rho_{i}\right) \rho_{i} \theta_{k}\right]\left(\cdot, d^{+}\right)=\sum_{k: I_{i} \subseteq P_{k}} \operatorname{Tr}\left[v\left(\rho_{i}\right) \rho_{i} \theta_{k}\right]\left(\cdot, d^{+}\right) \\
\quad \stackrel{(2.16)}{=}-\sum_{k: I_{i} \subseteq P_{k}} \operatorname{Tr}\left[v\left(\rho_{i-1}\right) \rho_{i-1} \theta_{k}\right]\left(\cdot, d^{-}\right) \stackrel{(2.15),(5.3)}{=} \operatorname{Tr}\left[v\left(\rho_{i}\right) \rho_{i}\right]\left(\cdot, d^{+}\right)
\end{aligned}
$$

and by recalling definition (2.18) this implies that the function $\sum_{k: I_{i} \subseteq P_{k}} \theta_{k}$ attains the boundary condition 1 . We can then repeat the same argument as before on the interval $I_{i}$ and conclude that (1.18) holds true on $] 0, T\left[\times I_{i}\right.$.
5.2. Proof of Theorem 1.4. We first establish existence, then uniqueness.
5.2.1. Existence. We fix a path $P_{k}$ and we term $I_{1}, \ldots, I_{n_{k}}$ the consecutive roads composing the path $P_{k}$. We now construct the solutions $\rho_{1}, \ldots, \rho_{n_{k}}$ and $\theta_{k}$. We argue inductively: first, we construct the solution on $I_{1}$. Next, we assume that we have constructed a solution on the road $I_{1}, \ldots, I_{j}$ and we construct it on $I_{j+1}$.

Construction of the solution on $I_{1}$. To construct $\rho_{1}$, we apply Proposition 2.6 with $\bar{u}=\bar{\rho}, u_{0}=\rho_{10}$ and $f(u):=u v(u)$. We conclude that there is an entropy admissible solution of (1.5), (1.11), (1.13) such that $0 \leq \rho \leq \rho^{*}$ and we recall that, owing to (1.7), the point $\rho^{*}$ is the point where the function $u \mapsto v(u) u$ attains its maximum. Next, we apply Theorem 2.15 with $] \alpha, \beta\left[=I_{1}\right.$ and $b=v\left(\rho_{1}\right)$ and conclude that there is a solution of $(1.8),(1.12),(1.14)$ defined on $I_{1}$. Since $0 \leq \bar{\theta}_{k} \leq 1$ and $0 \leq \theta_{k 0} \leq 1$, then by the comparison principle given in Theorem 2.15 we get (1.17) on $] 0, T\left[\times I_{1}\right.$. To conclude the existence proof on $I_{1}$, we are left to establish (1.18) on $] 0, T\left[\times I_{1}\right.$. To this end, we can argue as in Step 2 of the proof of Lemma 5.2.

Inductive step. We assume that we have constructed the solution on $I_{1}, \ldots, I_{j}$ and we construct it on $I_{j+1}$. More precisely, we assume that we have constructed the functions $\rho_{1}, \ldots, \rho_{j}$ and the function $\theta_{k}$ on $I_{1}, \ldots, I_{j}$. We also assume that $0 \leq \rho_{i} \leq$ $\rho^{*}$, for every $i=1, \ldots, j$, and that (1.17) and (1.18) are both satisfied on $] 0, T\left[\times I_{i}\right.$, for every $i=1, \ldots, j$. We term $d$ the junction point, that is, $d$ is the final point of the $\operatorname{road} I_{j}$ and the initial point of the road $I_{j+1}$. We proceed according to the following steps.

STEP 1: we show that

STEP 2: we construct the function $\rho_{j+1}$. We combine (1.7) and (5.5) and we conclude that there is a unique function $\bar{\rho}_{j+1} \in L^{\infty}(] 0, T[)$ such that

Next, we apply Proposition 2.6 with $] \alpha, \beta\left[=I_{j+1}, \bar{u}=\bar{\rho}_{j+1}\right.$ and we term $\rho_{j+1}$ the entropy admissible solution such that $0 \leq \rho_{j+1} \leq \rho^{*}$.

STEP 3: we define the function $\theta_{k}$ on $I_{j+1}$. By combining the fact that (1.17) is satisfied on $I_{j}$ with the inequality $v \geq 0$ and recalling that by assumption $I_{j+1} \subseteq P_{k}$ we get

To define $\theta_{k}$ on $I_{j+1}$ we apply Theorem 2.15 with $] \alpha, \beta\left[=I_{j+1}, b=v\left(\rho_{j+1}\right), \rho=\rho_{j+1}\right.$, and $\bar{\theta}=\theta_{k b}$, and we term $\theta_{k}$ the solution of (2.17). By applying the comparison principle, we get that (1.17) is satisfied on $I_{j+1}$. The equality (1.18) is established in Step 5.

STEP 4: we show that $\theta_{k}$ is a solution of (1.8) on $I_{1} \cup I_{2} \cup \cdots \cup I_{j+1}$. First, we point out that

We fix a path $P_{k}$, term $I_{1}, \ldots, I_{n_{k}}$ the consecutive roads composing $P_{k}$, and assume that there are two solutions $\rho_{1}, \ldots, \rho_{n_{k}}, \theta_{k}$ and $\rho_{1}^{\diamond}, \ldots, \rho_{n_{k}}^{\diamond}, \theta_{k}^{\diamond}$. We want to show that $\rho_{1}=\rho_{1}^{\diamond}$ a.e. on $] 0, T\left[\times I_{1}, \ldots, \rho_{n_{k}}=\rho_{n_{k}}^{\diamond}\right.$ a.e. on $] 0, T\left[\times I_{n_{k}}\right.$ and that $\rho_{i} \theta_{k}=\rho_{i}^{\diamond} \theta_{k}^{\diamond}$ a.e. on $] 0, T\left[\times I_{i}\right.$ for every $i=1, \ldots, n_{k}$. We argue inductively and proceed according to the following steps.

STEP 1: we establish the identities $\rho_{1}=\rho_{1}^{\diamond}$ and $\theta_{k}=\theta_{k}^{\diamond}$ on $] 0, T\left[\times I_{1}\right.$. Since $\rho_{1}$ and $\rho_{1}^{\diamond}$ are both entropy admissible solutions of the initial-boundary value problem (1.5), (1.11), (1.13) such that $0 \leq \rho_{1}, \rho_{1}^{\diamond} \leq \rho^{*}$, the identity $\rho_{1}=\rho_{1}^{\diamond}$ follows from the uniqueness part of Proposition 2.6. Next, we recall that $\theta_{k}$ and $\theta_{k}^{\diamond}$ are both solutions of the initial-boundary value problem

STEP 2: we assume that $\rho_{i}=\rho_{i}^{\diamond}$ and $\rho_{i} \theta_{k}=\rho_{i} \theta_{k}^{\diamond}$ on $] 0, T\left[\times I_{i}\right.$ for every $i=$ $1, \ldots, j$ and we establish the identities $\rho_{j+1}=\rho_{j+1}^{\diamond}$ and $\rho_{j+1} \theta_{k}=\rho_{j+1} \theta_{k}^{\diamond}$ a.e. on $] 0, T\left[\times I_{j+1}\right.$. We term $d$ the junction point between $I_{j}$ and $I_{j+1}$. We recall that by assumption both $\theta_{k}$ and $\theta_{k}^{\diamond}$ satisfy (1.18) on $] 0, T\left[\times I_{i}\right.$ for every $i=1, \ldots, n_{k}$. We apply Lemma 5.2, recall that $\rho_{j}=\rho_{j}^{\diamond}, \rho_{j} \theta_{k}=\rho_{j} \theta_{k}^{\diamond}$ on $] 0, T\left[\times I_{j}\right.$, and from (5.3) we deduce that $\operatorname{Tr}\left[v\left(\rho_{j+1}\right) \rho_{j+1}\right]\left(\cdot, d^{+}\right)=\operatorname{Tr}\left[v\left(\rho_{j+1}^{\diamond}\right) \rho_{j+1}^{\diamond}\right]\left(\cdot, d^{+}\right)$a.e. on $] 0, T[$. Owing to the first equality in (5.9), this yields the identity $g\left(\rho_{j+1}\right)\left(\cdot, d^{+}\right)=g\left(\rho_{j+1}^{\diamond}\right)\left(\cdot, d^{+}\right)$a.e. on $] 0, T[$, where $g$ is the same as in (1.7) and the traces $g\left(\rho_{j+1}\right)\left(\cdot, d^{+}\right)$and $g\left(\rho_{j+1}^{\diamond}\right)\left(\cdot, d^{+}\right)$are attained in the sense of (2.3). Since by assumption $\rho_{j+1}, \rho_{j+1}^{\diamond} \leq \rho^{*}$, then owing to Lemma 2.9, this implies that $\rho_{j+1}=\rho_{j+1}^{\diamond}$ a.e. on $] 0, T\left[\times I_{j+1}\right.$. Next, we recall that $\rho_{j} \theta_{k}=\rho_{j} \theta_{k}^{\diamond}$ a.e. on $] 0, T\left[\times I_{j}\right.$, we apply (2.16) and recall (2.18), and we conclude that $\theta_{k}$ and $\theta_{k}^{\diamond}$ are both solutions of the initial-boundary value problem

By the uniqueness part in the statement of Theorem 2.15 we conclude that $\rho_{j+1} \theta_{k}=\rho_{j+1} \theta_{k}^{\diamond}$ a.e. on $] 0, T\left[\times I_{j+1}\right.$.

Remark 5.3. Definition 1.3, Definition 5.1, and Lemma 5.2 extend to the case of more general networks than those considered in the present paper, i.e., networks containing other types of junctions than T-junctions. By arguing as in the proof of Theorem 1.4 one can show that if the density functions $\rho_{1}, \ldots, \rho_{h}$ are assigned, then one can construct the functions $\theta_{1}, \ldots, \theta_{m}$ satisfying Definition 5.1 and these functions are unique in the sense of (1.19). What is missing in the general case is that nothing guarantees that condition (1.18), or equivalently the junction condition (5.3), is satisfied.

## 6. Propagation of regularity and stability for the source-destination

 model.6.1. Proof of Theorem 1.5. By the uniqueness part in Theorem 1.4 it suffices to show that the solution of the distributional source-destination model constructed in section 5.2.1 satisfies Theorem 1.5. In particular, in the proof we show that, under the assumptions of Theorem 1.5, $r_{k}$ is bounded away from 0 for every $k=1, \ldots, m$ and hence the function $\theta_{k}$ is uniquely determined. We fix $k=1, \ldots, m$, consider the path $P_{k}$, and as in section 5.2.1 term $I_{1}, \ldots, I_{n_{k}}$ the consecutive roads composing $P_{k}$.

STEP 1: we establish the regularity estimates on $\rho_{1}$. We recall that $\rho_{1}$ is obtained by applying Proposition 2.6 , and by recalling (2.8) we arrive at
(6.1) $\operatorname{Tot} \operatorname{Var} \rho_{1}(t, \cdot) \leq \operatorname{Tot} \operatorname{Var} \bar{\rho}+\operatorname{Tot} \operatorname{Var} \rho_{10}+\left|\bar{\rho}\left(0^{+}\right)-\rho_{10}\left(a^{+}\right)\right| \quad$ for every $\left.t \in\right] 0, T[$,
where we have used Lemma 2.1 to define the function $\rho_{1}(t, \cdot)$ for every $t$. By applying the chain rule for $B V$ functions (see, for instance, [5, Theorem 3.96]) and using (1.5), we deduce from (6.1) a control on the total variation of the measure $\partial_{t} \rho_{1}$ on $] 0, T[\times] \alpha, \beta\left[\right.$ and conclude that $\rho_{1} \in B V(] 0, T[\times] \alpha, \beta[)$. Next, we recall the assumptions on the data and (2.5) and we conclude that

On the one hand, by (6.5) we trivially have $\sum_{k: I_{2} \subseteq P_{k}} \tilde{\theta}_{k} \geq \varepsilon$. On the other hand, by linearity $z:=\sum_{k: I_{2} \subseteq P_{k}} \theta_{k}$ solves

Also, owing to $(6.6), g\left(\rho_{2}\right)\left(\cdot, d^{+}\right) \in B V(] 0, T[)$. We now recall the construction in Step 2 of section 5.2.1 and in particular that the boundary datum $\bar{\rho}_{2}$ for $\rho_{2}$ is the unique function comprised between 0 and $\rho^{*}$ such that $g\left(\bar{\rho}_{2}\right)=g\left(\rho_{2}\right)\left(\cdot, d^{+}\right)$a.e. on $] 0, T[$. By using (6.7) and the chain rule for BV functions we infer that $\bar{\rho}_{2} \in B V(] 0, T[)$. Also, $\tilde{\varepsilon} \leq \bar{\rho}_{2} \leq \rho^{*}-\varepsilon$ for a suitable constant $\tilde{\varepsilon}>0$ which could be explicitely computed if needed. Next, we recall the construction in Step 3 of section 5.2 .1 and, by using formula (5.8) and recalling that $g\left(\bar{\rho}_{2}\right)$ is bounded away from 0 , we conclude that the boundary datum for $\theta_{k}$ at $d$ is

$$
\begin{equation*}
\theta_{k b}=\frac{\operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1}\right]\left(\cdot, d^{-}\right)}{g\left(\bar{\rho}_{2}\right)} \tag{6.8}
\end{equation*}
$$

and, owing to (6.3) and (6.7), this yields $\theta_{k b} \in B V(] 0, T[)$ and $\bar{\varepsilon} \leq \theta_{k b} \leq 1$ for some suitable constant $\bar{\varepsilon}$ which could be explicitly computed, if needed. We can repeat the argument at Step 1 and Step 2 and conclude that $\rho_{2} \in B V(] 0, T\left[\times I_{2}\right)$, $\theta_{k} \in B V(] 0, T\left[\times I_{2}\right)$.

STEP 4: by iterating the argument at the previous steps we conclude that, for every $i=1, \ldots, n_{k}, \rho_{i} \in B V(] 0, T\left[\times I_{i}\right)$ and $\theta_{k} \in B V(] 0, T\left[\times I_{i}\right)$. To conclude that actually $\theta_{k} \in B V(] 0, T\left[\times P_{k}\right)$ we apply a "gluing theorem" for $B V$ functions; see [5, Corollary 3.89].
6.2. Proof of Corollary 1.6. By the uniqueness part of Theorem 1.4 it suffices to establish the stability of the solution constructed in section 5.2.1. We fix $k=$ $1, \ldots, m$ and as in section 5.2 .1 we term $I_{1}, \ldots, I_{n_{k}}$ the consecutive roads composing the path $P_{k}$.

STEP 1: we show that $\rho_{1}^{n} \rightarrow \rho_{1}$ in $L^{1}(] 0, T\left[\times I_{1}\right)$. To this end, it suffices to recall the stability of the entropy admissible solutions of initial-boundary value problems with respect to perturbations in the data; see, for instance, [19, Theorem 4.3]. Owing to Lemma 2.8 we also have

$$
\begin{equation*}
g\left(\rho_{1}^{n}\right)\left(\cdot, d^{-}\right) \rightarrow g\left(\rho_{1}\right)\left(\cdot, d^{-}\right) \text {in } L^{1}(] 0, T[), \tag{6.9}
\end{equation*}
$$

where $d$ denotes the second extremum of the interval $I_{1}$.

Step 2: we show that $\rho_{1}^{n} \theta_{k}^{n} \rightarrow \rho_{1} \theta_{k}$ in $L^{1}(] 0, T\left[\times I_{1}\right)$.
Step 2A: we show that there is a sequence $\theta_{k}^{n}$ solving the initial-boundary value problem

$$
\left\{\begin{array}{l}
\partial_{t}\left[\rho_{1}^{n} \theta_{k}^{n}\right]+\partial_{x}\left[v\left(\rho_{1}^{n}\right) \rho_{\rho_{1}^{n}}^{n} \theta_{k}^{n}\right]=0,  \tag{6.10}\\
\theta_{k}^{n}(0, \cdot)=\theta_{k 0}^{n}, \quad \theta_{k}^{n}(\cdot, a)=\bar{\theta}_{k}^{n}
\end{array}\right.
$$

on $] 0, T\left[\times I_{1}\right.$ such that $\theta_{k}^{n} \stackrel{*}{\rightharpoonup} \theta_{k}$ weakly* in $L^{\infty}(] 0, T\left[\times I_{1}\right)$, where $\theta_{k}$ is a solution of the initial-boundary value problem (1.8), (1.12), (1.14). To this end, we recall that $\theta_{k}^{n}$ is constructed in section 5.2 .1 by applying Theorem 2.15, and by (2.19) this yields an $L^{\infty}$ bound on $\theta_{k}^{n}$ in terms of $\left\|\theta_{k 0}^{n}\right\|_{L^{\infty}}$ and $\left\|\bar{\theta}_{k}^{n}\right\|_{L^{\infty}}$. Owing to (1.15) and (1.16) we conclude that $\left\|\theta_{k}^{n}\right\|_{L^{\infty}}$ is uniformly bounded and hence weakly* converges (up to subsequences) to some limit function $\theta_{k}$. By using Step 1 we can pass to the limit in the distributional formulation of (6.10) and conclude that $\theta_{k}$ is a solution of (1.8), (1.12), (1.14).

Step 2B: we show that $\rho_{1}\left(\theta_{k}^{n}\right)^{2} \stackrel{*}{*} \rho_{1}\left(\theta_{k}\right)^{2}$ weakly* in $L^{\infty}(] 0, T\left[\times I_{1}\right)$. Owing to the proof of [25, Proposition 3.11], $\left(\theta_{k}^{n}\right)^{2}$ is a solution of the initial-boundary value problem (6.10) with $\theta_{0 k}^{n}$ and $\bar{\theta}_{k}^{n}$ replaced by $\left(\theta_{0 k}^{n}\right)^{2}$ and $\left(\bar{\theta}_{k}^{n}\right)^{2}$, respectively. Also, $\left\|\left(\theta_{k}^{n}\right)^{2}\right\|_{L^{\infty}}$ is uniformly bounded because so is $\left\|\theta_{k}^{n}\right\|_{L^{\infty}}$ and hence, up to subsequences, $\left(\theta_{k}^{n}\right)^{2}$ weakly* converges in $L^{\infty}(] 0, T\left[\times I_{1}\right)$ to some limit function $\gamma$. Since $\rho_{1}^{n} \rightarrow \rho_{1}$ strongly in $L^{1}(] 0, T\left[\times I_{1}\right)$ by Step 1 , this implies that $\rho_{1}^{n}\left(\theta_{k}^{n}\right)^{2} \stackrel{*}{\rightharpoonup} \rho_{1} \gamma$ weakly* in $L^{\infty}(] 0, T\left[\times I_{1}\right)$. By passing to the limit in the distributional formulation we get that $\rho_{1} \gamma$ is a solution of (6.10) with $\theta_{0 k}^{n}$ and $\bar{\theta}_{k}^{n}$ replaced by $\left(\theta_{0 k}\right)^{2}$ and $\left(\bar{\theta}_{k}\right)^{2}$, respectively. Since by [25, Proposition 3.11] $\rho_{1}\left(\theta_{k}\right)^{2}$ is a solution of the same initial-boundary value problem, then by the uniqueness part of Theorem 2.15 we have $\rho_{1} \gamma=\rho_{1}\left(\theta_{k}\right)^{2}$.

Step 2C: we conclude the proof of Step 2 . We recall that $\rho_{1}^{n} \rightarrow \rho_{1}$ strongly in $L^{1}(] 0, T\left[\times I_{1}\right)$ owing to Step 1: by Step 2A, this implies that $\rho_{1} \theta_{k}^{n} \stackrel{*}{\checkmark} \rho_{1} \theta_{k}$ weakly* in $L^{\infty}(] 0, T\left[\times I_{1}\right)$ and henceforth weakly in $L^{2}(] 0, T\left[\times I_{1}\right)$. By Step 2B, it also implies that $\left(\rho_{1} \theta_{k}^{n}\right)^{2} \xrightarrow{*}\left(\rho_{1} \theta_{k}\right)^{2}$ weakly* in $L^{\infty}(] 0, T\left[\times I_{1}\right)$ and henceforth weakly in $L^{2}(] 0, T\left[\times I_{1}\right)$. We conclude that $\rho_{1} \theta_{k}^{n} \rightarrow \rho_{1} \theta_{k}$ strongly in $L^{2}(] 0, T\left[\times I_{1}\right)$ and henceforth strongly in $L^{1}(] 0, T\left[\times I_{1}\right)$.

STEP 3: we show that $\bar{\rho}_{2}^{n} \rightarrow \bar{\rho}_{2}$ strongly in $L^{1}(] 0, T[)$, where $\bar{\rho}_{2}^{n}$ and $\bar{\rho}_{2}$ are the boundary data for $\rho_{2}^{n}$ and $\rho_{2}$, respectively. We recall that, by the construction in section 5.2.1, $\bar{\rho}_{2}$ is the function confined between 0 and $\rho^{*}$ such that

$$
g\left(\bar{\rho}_{2}\right)=\sum_{k: I_{2} \subseteq P_{k}} \operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1} \theta_{k}\right]\left(\cdot, d^{-}\right),
$$

where $d$ is the second extremum of $I_{1}$. Hence, to establish the convergence $\bar{\rho}_{2}^{n} \rightarrow \bar{\rho}_{2}$ it suffices to show that $\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\left(\cdot, d^{-}\right) \rightarrow \operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1} \theta_{k}\right]\left(\cdot, d^{-}\right)$strongly in $L^{1}(] 0, T[)$ for every $k=1, \ldots, m$.

Step 3A: we show that $\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\left(\cdot, d^{-}\right) \xrightarrow{*} \operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1} \theta_{k}\right]\left(\cdot, d^{-}\right)$weakly* in $L^{\infty}(] 0, T[)$. Owing to [3, Proposition 3.2] and to the proof of [20, Lemma 3.3], $\left\|\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\right\|_{L^{\infty}}$ is uniformly bounded in terms of $\left\|\rho_{1}^{n}\right\|_{L^{\infty}}$ and $\left\|\theta_{k}^{n}\right\|_{L^{\infty}}$ and hence up to subsequences converges weakly* in $L^{\infty}(] 0, T[)$ to some function $\delta$. By recalling Step 1 and Step 2 and passing to the limit in the definition of distributional trace we get that $\delta=\operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1} \theta_{k}\right]$.

Step 3B: by recalling Step 2B we can repeat the same argument as in Step 3A and conclude that $\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n}\left(\theta_{k}^{n}\right)^{2}\right]\left(\cdot, d^{-}\right) \xrightarrow{*} \operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1}\left(\theta_{k}\right)^{2}\right]\left(\cdot, d^{-}\right)$weakly* in $L^{\infty}(] 0, T[)$.

Step 3C: owing to the trace renormalization property given by [25, Theorem 4.2] we have

$$
\begin{gathered}
\left(\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\left(\cdot, d^{-}\right)\right)^{2} \stackrel{[25, \text { Theorem } 4.2]}{=} \operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n}\left(\theta_{k}^{n}\right)^{2}\right]\left(\cdot, d^{-}\right) \operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n}\right]\left(\cdot, d^{-}\right) \\
\\
\stackrel{(2.15)}{=} \operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n}\left(\theta_{k}^{n}\right)^{2}\right]\left(\cdot, d^{-}\right) g\left(\rho_{1}^{n}\right)\left(\cdot, d^{-}\right) .
\end{gathered}
$$

Owing to Step 3B and (6.9) this yields that $\left(\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\left(\cdot, d^{-}\right)\right)^{2}$ weakly* converges in $L^{\infty}(] 0, T[)$ to $\left(\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\left(\cdot, d^{-}\right)\right)^{2}$ and by recalling Step 3A and repeating the same argument as in Step 2C it implies that $\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\left(\cdot, d^{-}\right)$strongly converges in $L^{1}(] 0, T[)$ to $\operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1} \theta_{k}\right]\left(\cdot, d^{-}\right)$.

Step 4: owing to Step 3, we can repeat the same argument as in Step 1 and conclude that $\rho_{2}^{n} \rightarrow \rho_{2}$ in $L^{1}(] 0, T\left[\times I_{2}\right)$. Next, we recall that, by the analysis in section 5.2.1, $\theta_{k}$ is defined on $] 0, T\left[\times I_{2}\right.$ by solving an initial-boundary value problem analogous to (5.8) and with boundary datum $\theta_{k b}$ given by (5.8). We now want to show that $\rho_{2}^{n} \theta_{k}^{n} \rightarrow \rho_{2} \theta_{k}$. Note that to repeat the same argument as in Step 2 it suffices to show that

$$
\begin{equation*}
\theta_{k b}^{n} g\left(\bar{\rho}_{2}^{n}\right) \rightarrow \theta_{k b} g\left(\bar{\rho}_{2}\right), \quad\left(\theta_{k b}^{n}\right)^{2} g\left(\bar{\rho}_{2}^{n}\right) \rightarrow\left(\theta_{k b}\right)^{2} g\left(\bar{\rho}_{2}\right), \text { in } L^{1}(] 0, T[) . \tag{6.11}
\end{equation*}
$$

Step 4A: we establish the first convergence result in (6.11). It suffices to recall that, owing to (5.8), $\theta_{k b} g\left(\bar{\rho}_{2}\right)=\operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1} \theta_{k}\right]\left(\cdot, d^{-}\right)$, and then recall Step 3C.

Step 4B: we establish the second convergence result in (6.11). We want to apply the Lebesgue dominated convergence theorem. First, we recall that $\left|\theta_{k b}^{n}\right| \leq 1$ owing to (5.7) and we conclude that $\left\|\left(\theta_{k b}^{n}\right)^{2} g\left(\rho_{2}^{n}\right)\left(\cdot, d^{+}\right)\right\|_{L^{\infty}}$ is uniformly bounded. We are left to establish the a.e. pointwise convergence. First, we recall Step 3C and conclude that, up to subsequences, $\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\left(t, d^{-}\right)$converges to $\operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1} \theta_{k}\right]\left(t, d^{-}\right)$and $g\left(\bar{\rho}_{2}^{n}(t)\right)$ converges to $g\left(\bar{\rho}_{2}(t)\right)$ for a.e. $\left.t \in\right] 0, T[$. We fix a $t \in] 0, T[$ such that the above convergence results hold true and we distinguish between two cases. If $g\left(\bar{\rho}_{2}(t)\right) \neq 0$, then for $n$ sufficiently large

$$
\begin{aligned}
\left(\theta_{k b}^{n}(t)\right)^{2} g\left(\bar{\rho}_{2}^{n}(t)\right) & =\frac{\left(\operatorname{Tr}\left[v\left(\rho_{1}^{n}\right) \rho_{1}^{n} \theta_{k}^{n}\right]\left(t, d^{-}\right)\right)^{2}}{g\left(\bar{\rho}_{2}^{n}(t)\right)} \rightarrow \frac{\left(\operatorname{Tr}\left[v\left(\rho_{1}\right) \rho_{1} \theta_{k}\right]\left(t, d^{-}\right)\right)^{2}}{g\left(\bar{\rho}_{2}(t)\right)} \\
& =\left(\theta_{k b}(t)\right)^{2} g\left(\bar{\rho}_{2}(t)\right) \quad \text { as } n \rightarrow+\infty .
\end{aligned}
$$

If $g\left(\bar{\rho}_{2}(t)\right)=0$ we argue as follows: since $\left|\theta_{k b}^{n}(t)\right| \leq 1$, then $\left|\left(\theta_{k b}^{n}(t)\right)^{2} g\left(\bar{\rho}_{2}^{n}(t)\right)\right| \leq$ $g\left(\bar{\rho}_{2}^{n}(t)\right)$ and hence it converges to 0 as $n \rightarrow+\infty$. This concludes the proof of the a.e. pointwise convergence and hence of Step 4.

Step 5: by iterating the argument at the previous steps we establish the desired stability result.
